Meeting Minutes Dec 13, 2006

- 1) Action on the following Parliamentary Items was taken.
 - a) The meeting was called to order by Chair Fred Lindahl at 6:36 p.m.
 - b) No introductions were made.
 - i) The Agenda was approved with no additions or deletions.
 - c) The Meeting Minutes for Nov 8, 2006 were approved unanimously.
 - d) The Treasurer's Report for Oct 31, 2006 was placed on file, with balances of:
 - i) \$887.25 in the KenTal Planning Committee account.
 - ii) \$201.78 in the Police Storefront account
 - iii) The treasurer, Louise Guarnotta, mentioned that rent at the church is \$25/month (\$275/year), the PO Box is \$85/year, and the average income is \$13/month (\$143/year). (The Secretary has calculated this is a net loss of \$217/year. Calculations used 11 months/year where applicable, as we don't meet in August.)
- 2) Non-Agenda Public Comment.
 - a) John Hartley, President of the Friends of the Library reported that the Friends would be seeking community input on the library remodel at a workshop on Saturday, Feb. 24, 8:30 11:00 a.m., at the Kensington Community Church.
 - b) Allard Jansen reported on the status of Kensington Terrace (the project name for the Emerald gas station site). They are expecting an assessment letter on Dec 18. He would like to present at the next Project Review subcommittee meeting, and to the full board on Jan 10.
 - c) Guy Hanford reported that the Kensington Vine (wine, sandwiches, pizza) will be opening soon.
- 3) Communications were received from representatives of our elected officials:
 - a) Todd Gloria from the office of Congresswoman Susan Davis (office ph. 619.280.5353) could not attend, as he was double-booked.
 - b) There was no report from the new Mayor's office.
 - c) Toni Atkins' representative, April Chesebro ((phone) 619.236.6633, (email) achesebro@sandiego.gov.) handed out copies of the Toni Times, which had crime prevention tips, andd reported that:
 - i) Toni has submitted questions about the indemnification memo to the mayor and the city attorney...no answer, yet.
 - ii) Pat Norris is the new Community Relations Officer.
 - iii) She left fliers detailing how to report burned out or damaged streetlights (call 619.527.7500 or go online to http://apps.sandiego.gov/streetdiv/).
 - d) Marlon Pangilinan (ph. 619.235.5293, email mpangilinan@sandiego.gov) reported on the status of the by-laws shell progress. There has been no substantive change; this may cause an postponement to the deadline for community groups getting their own by-laws adopted.
- 4) Action items

 a) Adams Ave 50 foot height limit – Marlon Pangilinan – The 50 foot height limit along the Adams Ave corridor - Kensington (7:20 - 10 min presentation/ 10 min discussion).

Marlon reported that:

- 1. The City noticed the last Plan Update (wherein the 50 ft ht limit was established) thru the San Diego Public Record Reporter (July 17, 2000).
- 2. *All* property owners affected by any proposal to lower the height limit would have to agree to it.
- 3. Lowering the height limit could be effected thru another Plan Update of an amendment to the Community Plan.

Priscilla Berge offered that this might best be approached by designating certain areas as "conservation areas".

A motion was made to table this topic until we had more information on the conservation area approach, and passed unanimously.

b) Project Name: Nextel Braeburn – 4440 Braeburn Road – Project # 83951 – Omar Passons – Site Development Permit and Conditional Use Permit – Replace an existing telcom site with a new 240 sq ft equipment building/roof deck. A total of 15 panel antennas would be mounted on the exterior the building, 5 on each side of the 3 sides facing the canyon. Two GPS antennas would be mounted on roof building - Kensington (7:20 - 10 min presentation/ 10 min discussion).

The representative was not ready, so this item tabled.

 - i) There were 2 notices of application:
 - (1) 4142 Adams Ave (aforementioned Kensington Terrace). The applicant will be asking for an approximate 4% increase in FAR (floor area ratio).
 - (2) 4166 Adams Ave. New 9 unit building plus 4000 sq ft of retail. Will be asking for a height variance (to 35 ft), and a decrease in the width of the driveway (from 20 to 18 ft). Have received no assessment letter yet.
 - ii) Roger reported that the center of the road on Rochester east of Marlborough has subsided, and that the patches on Marlborough between Rochester and Hilldale from sewer/water work are substandard.
 - b) Transportation and Safety. Chance Bilmeyer (business owner on Adams) would like to calm traffic on Adams; proposing white striping along the sides of Adams Ave, but is soliciting other ideas. For instance, crosswalks

(Edgeware and Kensington Aves at Adams), or one way streets.

- c) Public Facilities. (D Laman)
 - i) Mary Faye Elementary continues to go up/.
- d) By-laws, Membership and Communications. (W Budd) There will be a by-laws meeting in Dec. Louise G reported that meeting would not be subject to the Brown Act, and so need not be noticed.

 - ii) Community Planners Committee. (Guarnotta/Hebrank). Louise sent a report regarding the Brown Act..
