Project Location: 7853 Via Capri, APN: 353-170-25
Project Description: Concept review, not yet submitted to city. The scope of project is to add a second story addition over the existing garage, adjacent to existing second floor addition. Existing 5,118 square foot single family residence. The second floor addition adds 432 square feet to the existing 1,258 square feet second floor. The height would increase 12'-0", from 16'-6" to 28'-6", in keeping with other two story residences in the area. The lot is 20,625 square foot parcel zoned LJSPD-SF. The proposed addition would increase the FAR to 28%; the existing FAR is 27%. The existing front wall observes a 25'-0" front yard setback. There is no change in side or rear yard setbacks. The site is 72% landscaped with 27% developed with pavement and structure. The Owner has obtained a letter of endorsement from the immediate neighbor to the east that would be most affected by this project.

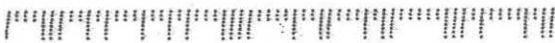
