- 2. Community Planners Committee activities and information Chair reporting in absentia.
 - a. Airports land use compatibility guides include Normal Heights as an "influence area" DVDs and online resources with details are available as sent via e-mail. City Council consideration of the guides was scheduled for July 28th.

Montgomery Field- Within the City of San Diego, the Montgomery Field airport influence area is proposed to include the communities of Clairemont Mesa, College Area, Kearny Mesa, Linda Vista, Eastern Area, Kensington-Talmadge, Mission Valley, Navajo, Normal Heights, North Park, Serra Mesa, Tierrasanta, University, and Uptown; and would primarily impact areas within Clairemont Mesa, Kearny Mesa, Linda Vista, Navajo, Serra Mesa, and Tierrasanta.

- b. Community Plan Preparation Manual draft was discussed and decided to need further review; potentially reinforcing that Planning Groups select their own committees, not have members appointed by City Council or others. The Normal Heights Community Plan needs updating but is not presently among those community plans scheduled for update.
- c. The City Council has decided that Planning Group subcommittee members will also be indemnified, but their membership must be documented in a Planning Groups minutes.
- d. Reminder regarding Water Conservation City is at State 2 Water Alert level of conservation with MANDATORY WATER USE RESTRICTIONS. See

- e. Chair, Jim Baross, attended Planning Chairs Operation Workshop, June 29^{th.} The workshop included information about parliamentary procedure among other issues.
- f. San Diego River Park Master Plan update was provided. Neighboring Planning Groups may get presentations at their/our meeting. The primary communities affected are Mission Valley, Navajo, Tierrasanta and East Elliot.
- g. An Attorney General opinion about the Brown Act and prohibitions for members of Planning Groups exchanging information about a pending issue or decision was provided to Planning Group members. In summary the opinion means:

We should not have e-mail or other exchanges outside of a public meeting that include -

"... substantive discussions 'which advance or clarify a member's understanding of an issue, or facilitate an agreement or compromise amongst members, or advance the ultimate resolution of an issue' (Cal. Dept. of Justice, The Brown Act, Open Meetings For Local Legislative Bodies (1994) p. 12) regarding an agenda item."

"We find no distinction between e-mails and other forms of communication such as leaving telephone messages or sending letters or memorandums. If e-mails are employed to develop a collective concurrence by a majority of board members on an agenda item, they are subject to the prohibition of section 54952.2, subdivision (b).

- h. The City of San Diego Bicycle Master Plan update is scheduled to be heard at City Council August 6th.
- i. One Planning Group had their meeting canceled because their agenda had not been publicly posted. Ours is.
- j. Committee differed with Development Services on the subject of whether level 2 projects, those in "Substantial Conformance" should be referred to and reviewed by the appropriate Planning Group. CPC recommended that Planning Groups have the opportunity to review these.
- k. CPC recommended that the development permits review appeal procedure be extended from 10 business days to 20 business days to give sufficient time for a Planning Group to decide and develop an appeal.
- 3. Mid-City Mobility Coalition monthly community bike ride will be August 8, 10AM from the City Heights Farmers Market. It's to be a "Bicycle Blast" and "Get Wet Ride" with water play and optional swim at C.H. Community Pool after the riding.
