The mandatory water use restrictions included with the Level 2 Drought Alert Condition will affect all City Water Department customers. Under Level 2, all voluntary conservation practices currently recommended by the City become mandatory. In addition to a host of specific requirements spelled out in the Emergency Water Regulations, Water Department customers will be required to:

- Water lawns and landscape only between 6 p.m. and 10 a.m.
- Water only three times a week from June through October.
- Know their watering days:

- When taking their car to a car wash, use only those that recycle their water.
- Wash their cars at home between 6 p.m. & 10 a.m. only, and use a bucket and a hose with a shut-off nozzle.
 - c. Fire Hazard Zones Map explained. Concerns remain for lack of differentiation of hazard levels and economic impact of new building restrictions. Website is: www.sandiego.gov/fireandems/forms/map.shtml. Also at the libraries.
 - 3. Mid-City Mobility Coalition monthly community bike ride will be June 13, 10AM from the City Heights Farmers Market. It's to be a "Bicycle Blast" and "Ice-cream Social" with bike bells, horns, playing cards in spokes, and other sonorous sound equipment to bring attention to bicycling.
 - 4. Air Quality study report given to I-15 Mid City BRT stations working Group. Mid City's air quality apparently is relatively good and far under Federal standards at the locations tested along I-15; near Central Elementary and Wilson Jr. High.
 - 5. The City Planning & Community Investment (CPCI) Department is pleased to announce that the Community Orientation Workshop (COW) Training has now gone Electronic and can be taken online at your convenience. The Department is now offering the Electronic COW or E-COW, as an alternative which allows Community Planning Group (CPG) Members to take the training online in lieu of attending the COW training session. Ordinance # O-19842 "An Ordinance Providing for Defense and Indemnification of Community Planning Groups" requires that CPG members attend the first COW available to them either electronically or in person. Therefore, with the E-COW now live on our website, CPG members can easily take the training at their convenience prior to participating in their first Planning Group meeting. CPCI will continue to host an annual COW training session for those who prefer to take the training in a traditional classroom setting with a variety of useful breakout sessions. Additionally, veteran Community Planning Group members who have already taken the COW may be interested in taking the E-COW as a refresher course, as it is based upon the most recent updates to City Policies, Ordinances and the Brown Act.
