- 1. Development Projects for review
 - a. No current Historical Reviews were provided for review. (Interested members may request to be added to NH Historical Housing Review Committee email distributions.)
 - b. No current development projects have been received for review.
- 2. Nomination and election of qualifying community members to the NHCPG Board, as appropriate to fill remaining vacant one-year terms; to March 2014.
- 3. Report of Adams Unplugged event for operating information booths and T-shirt sales. Potential recommendations and decisions for use of funds.
- 4. Notice of Two Week Review and Comment Period through May 17th of Draft Amendments to the Decision Process for Capital Improvement Projects (CIP) to reduce the processing times and costs associated with making decisions on CIPs. Chair recommends approving the draft changes.
- 5. Proposed Code of Conduct rules and values for how Board members will treat, support and communicate with each other and how we will participate and cooperate in making decisions. We would use these in all aspects of our Board work assignments, meetings and discussions. Shall these be provided for inclusion to our NHCPG Bylaws?
 - a. We will show respect by not cross-talking or back talking during discussions.
 - b. We agree that one person speaks at a time; there will not be side conversations.
 - c. We will treat each other with mutual respect and/or civility. We will be aware of and responsible for our words and our actions.
 - d. We will seek to build trust and safety within the group so that everyone feels safe enough to express opinions and present relevant information.
 - e. We acknowledge a member's right not to speak on a particular issue but we agree to participate in discussions and contribute to decisions.
 - f. We will maintain a sense of humor. We will de-personalize our conversations and focus on discussing issues.
 - g. We will listen without interrupting, be nonjudgmental and try to keep an open mind on issues until it is time to decide.

- h. We will regard feelings as valid.
- i. We will make "I" statements. We will speak for ourselves, not the group or others (present or absent)
- j. We will respect the group's time and timetables. Each person will have a chance to speak their mind. However, our contributions will be brief and focus on bringing new facts or approaches and we will try to not be redundant.
- k. We will give feedback in a constructive way. We will avoid "talking down" or attacking others.
- I. We will strive to understand those who disagree with us. We will validate others.
- m. We will be open to changing our minds.
- 6. How we will encourage community member participation for improving NH; perhaps with the Capital Improvement Project annual review and recommendation process such as last year's Ice-cream Social Brain-storming.
