## MINUTES February 21, 2007

### CALL TO ORDER

The meeting was called to order by Chairman Rob Hixson.

### **APPROVAL OF MINUTES**

Alejandra Mier y Teran recommended the following corrections to the January 2007 minutes:

- Under the Chamber subcommittee report, change the date of Mexport to May 3.
- Under the Border Transportation report, correct the sentence to say that Senator Ducheny was scheduling a meeting between Will Kempton, Gary Gallegos, and Pedro Orso Delgado to discuss the situation.

Jimmy Ayala made a motion to approve the minutes, as amended. The motion was seconded by Alejandra and passed 15-0-1, with Javier Serhan abstaining since he did not attend the January meeting.

## CHAIRMAN'S REPORT

Chair Hixson reported on the following items received last month:

- Plans for World Petrol on La Media/Otay Mesa Road
- LU&H information
- TransNet Information
- SANDAG

Chair Hixson reported on the RFQ for Brown Field. The City is considering doing an independent Master Plan. Tom Ricotta added that the FAA may not have enough funds available for a Master Plan.

## SPECIAL AGENDA ITEM: OTAY MESA COMMUNITY PLAN UPDATE

Planning Commission Workshop: Theresa Millette (City of San Diego) distributed printed slides from the focused workshop on January 18. Over one hundred people attended the workshop, and reports were given by Curtis Spencer (logistics expert) and City Staff. Chair Hixson commented that live/work areas should be included in industrial areas because there are many people who would be interested. Theresa said there is a designation within the General Plan that allows for that use. Judd Halenza asked how truck parking fit into the industrial inventories. Theresa explained that they are represented in the "Interim Acres" category. Steve Gross said that he does not agree with the range of acreage and recommended an audit be conducted on parcels of industrial land. Theresa said that she will relay Steve's feedback. Chair Hixson explained that the City is taking their numbers from SANDAG. He has recommended changes on the number to the City and feels that the numbers are fairly accurate at this point. He suggested that Steve make recommended changes to the City as well. Alejandra Mier y Teran said that SANDAG has based their numbers on gross data, rather than major arterials and the burrowing owl factor. She agreed that there should be an audit conducted, which would take between 4-6 months. Steve then asked about setbacks from freeways and whether that would be analyzed in the EIR. Theresa said that it would be addressed, but this is a PEIR. Each project completes an individual environmental analysis. Steve said that he doesn't think that the reports referenced are comparing apples to apples. The SANDAG report uses one set of criteria and then the ERA report uses another set of criteria. It was decided that Steve would meet with Manjeet and Theresa with his questions.

SCHEDULE/VISION STATEMENT: Theresa then distributed revised copies of the plan update schedule. The LU&H workshop was cancelled on February 28. There will be a Planning Commission workshop in March and they hope to get on the LU&H docket in July/August. Jimmy Ayala suggested that the City present the plan update at LU&H sooner rather than later. Alejandra Mier y Teran asked when City staff would make a recommendation on a scenario. Theresa said that she wasn't sure when they would do that. She distributed copies of the draft vision statement. Tony Evans asked whether the "Create Complete Places" bullet point implies that there will be heavy residential in Otay Mesa. Alejandra Mier y Teran commented that it implies that there will be balanced uses within the community, but she could see how that could be interpreted to mean residential. Theresa said that they could work on adapting that bullet point.

**FACILITIES:** Manjeet Ranu (Urban Counsel) explained that they have evaluated the scenarios and the population household study to get an idea of household sizes in Otay Mesa. They determined that the household size is large for multi-family and single-family homes, which is consistent with SANDAG's estimates. He distributed draft general locations for public facilities such as parks, schools, fire stations, police stations. They are based on the draft General Plan Update, household survey, and the land use plan scenarios for density and intensity. Pepper Coffey asked whether or not the current high school is at capacity because they are servicing students from San Ysidro. Manjeet was not sure, but estimated it could be due to No Child Left Behind or perhaps a high number of ESL learners at that school. Tom Story asked if another police station would be included in the plan. Manjeet said it depends on the existing facility in San Ysidro and explained that the need is determined based on response time. Alejandra asked about the schools that were being proposed next to freeways and whether that would be evaluated in the EIR. Manjeet said that the general suitability is evaluated in the EIR, but the school districts will study the impacts on their own.

Tom Tomlinson recommended that the parks be located closer to the residents and also suggested relocating the education campus north across the freeway.

## **GOVERNMENT LIAISON REPORTS**

## A. Councilmember Hueso's Office

Whitney Benzian reported that the Brown Field RFQ's should be submitted by February 23. A process committee will narrow down the list to five projects. Councilmember Hueso will not meet directly with the developers; instead staff will handle the meetings. They met with Rueben Barrales (CEO of the San Diego Regional Chamber) to discuss Otay Mesa and SR905 and their importance in the region. They also met with Alan Bersin (Chairman of the San Diego Airport Authority) and discussed the Brown Field RFQ process, as well as the cross border terminal. They are still meeting with Caltrans, SANDAG and various elected officials on the status of SR905. He said there would be another meeting next week on the issue. Tom Story asked if there are opportunities for members of the community to serve on the selection committee for the Brown Field RFQ. Whitney said he believes a representative from the community will be selected and he will look into this further.

## MONTHLY REPORTS

## A. CPC

Mel Ingalls reported that he and Chair Hixson attended training on the Brown Act. He alerted the planning group members about the changes to the Indemnification Ordinance. Planning group members are no longer indemnified according to the City Attorney. If anyone takes action against you as a planning group member, you are not protected by the City Attorney until there is a settlement. Basically, you would cover your legal fees until time of a settlement. Judd Halenza said that to not have protection is ridiculous and there is no reason members should have to assume liability. Theresa Millette said that Betsey McCullough is in the process of updating the bylaws shell and the Council Policy to incorporate the City Attorney's opinion on the Brown Act. There will also be another COW on April 29th that will address this issue. Tom Story suggested that the group request how to properly indemnify planning group members.

Chair Hixson mentioned that in the training, they addressed issues such as posting agendas in advance of meetings and not discussing agenda items outside of noticed meetings. Tom Story asked if the group could get a copy of the City Attorney's opinion. Chair Hixson said he would send it to the group.

### **B.** Border Transportation

Alejandra Mier y Teran reported that she received an update from Pedro Orso Delgado on SR905. They are still looking at \$80M as a worst case scenario on the ROW acquisition, and have settled with Handler. Caltrans has said that they will not allocate additional funds for ROW. They are going to request extension for STIP funds for an additional eight months, which would mean construction would begin the summer of 2008.

### E. Heavy Industrial Use Committee

Emil Wohl reported that they have had a series of workshops, soliciting comments from the City on where Heavy Industrial Uses should be located in the community. If the CUPs are expiring soon and the City is going police their own permits, there will need to be even more coordination between the City and the subcommittee. He suggested continuing to meet with Theresa on a regular basis to discuss this issue.

## F. San Diego Airport Advisory Committee

Tom Ricotta reported on maintenance projects underway at Brown Field. There will be new fencing on the north side that will secure 2/3 of the airport. They will purchase new lighting and also will resurface the runways. Tom Tomlinson then reported that the ALUC (Airport Land Use Commission) will make updating the Brown Field ALUCP (Airport Land Use Compatibility Plan) a priority.
