The meeting will be held to gather OMNCPG and public input about various proposed Capital Improvement Projects (CIP) projects in the Otay Mesa Community Plan area. The City of San Diego provided a list of these actual proposed CIP, and they want a recommendation ranking the most important to the least important. If approved, this special meeting of the OMNCPG has been tentatively scheduled for Wednesday, October 24th, at 6:30 pm, at the Otay Mesa Nestor Library meeting room.
- (7:00) 8. **Unfinished business:** The June 13, 2012, OMNCPG agenda contained an “action item” to consider recommendation of a letter of approval regarding “dedication” of about 29.85 acres of open space owned by the City of San Diego, located within the Otay Mesa Nestor Community Plan area. At that meeting, the item was voted to be tabled until more information was received from the City of San Diego Planning Department staff. At the July 11, 2012, meeting, the group voted to place this item again on the table. However, this item was not on that July, 2012, agenda. Although this item was on the September, 2012, OMNCPG agenda, a quorum was not present to vote on it. A motion to place this “action item” on the table and vote on it must now be considered by the OMNCPG at this noticed regular meeting.
