- A. **Barnett Residence (4403 Del Monte Ave):** after discussion a motion by J. Lester to approve as presented was approved MSC (10 DD, CJ, DW, DK, SKM, MH, JL, DC, SK, HK) – (1JS)- 0

III New/Old Business:

- A. **Rock Church special event permit:** after discussion, a motion by board member J. Shumaker to approve endorsement of special permit (1 yr on Sundays) for tables within temp. closed portion of Truxton St. in front of the Rock Church was approved MSC (8 DD,DW,JS,DK,DC,SKM,HK,JL supported) –(2 MH,CJ opposed) - 0 abstained - 1 recused SK).
- B. **Community presentation for Sewer & Water improvements Group 676 (Jericho Gallardo):** those present were presented diagrams of areas scheduled for repairs/replacements. Estimated completion = June 2009
- C. **Community presentation for Water improvements Group 3010 (Jericho Gallardo):** those present were presented diagrams of areas scheduled for replacements. Estimated completion = Mar 2009

IV. Sub-Committee Reports:

- A. Election committee (Ad Hoc): D. Wylie reported PL library is reserved 4PM- 8PM for voting in election Mar 19th.
- B. Project Review: S. Kilbourn McGee- reported that subcommittee is working on templates for some operational standards to help applicants and subcommittee members, announced some future projects coming to the PR
- C. Bylaws (Ad Hoc): D. Wylie reported should have typing of draft complete for circulation by next board meeting
- D. Airport Authority, ANAC (Airport Noise Advisory Comm.), ATAG (Airport (land use compatibility) Technical Advisory Group) and NTAG(Noise Tech. Advisory Group) : S. Khalil reported that he is recommending PCPB issue a letter to express concern on the parking structure element and traffic analysis of proposed master plan- recommending reduction of parking structure as well as new studies of traffic components and impacts which appear flawed in their traffic conclusions- after discussion if this was the only position board should take on review of the proposed EIR, board requested subcommittee chair to draft letter and deliver draft to board (in a public forum) so verbiage could be properly reviewed by board prior to issuing letter by board and signed by board chair- comments on EIR by PCPB board due next week.
- E. BU Digester Gas (Ad Hoc): D. Davis (don't anticipate action for a while) – waiting for developer to complete plan check for building permits get under construction.
- F. Traffic and Transportation: G. Halbert absent (no report)
- G. North Bay Planning/Dev: J. Lester reported no meeting until Feb 4 (4 meetings each year)
- H. Midway Planning: D. Kaup reported that meeting is changed to third wed (therefore next is Jan 21st)
- I. Environment: D. Cohen reported meeting with Navy scheduled Jan 16th 2009 (Navy trying to maximize efficiency of clean up method in Channel)
- J. Parks Rec: H. Kinnaird –reported that Charlie Best (community member) is being considered- Charlie requested by board to come to next meeting to meet Board members prior to being voted on subcommittee.
