### **MINUTES September 20, 2006**

#### **CALL TO ORDER**

The meeting was called to order by Chairman Rick Smith. Rachele Melious, John Weede, Mary Jean Word, Susan Marshall, Craig Levitt, and Saeed Askari were present. Barbara Baker was excused.

#### **APPROVAL OF MINUTES**

Rachele Melious made a motion to approve the minutes for March, May, and July meetings. The motion was seconded by Mary Jean Word and it passed unanimously.
