### **MINUTES October 18, 2000**

#### **CALL TO ORDER**

#### **APPROVAL OF MINUTES**

Upon a motion by Marian Pedrin and a second by Michael Graham, the minutes from the September meeting were unanimously approved.

#### **CHAIRMAN'S REPORT**

Chairman Rick Smith reported on the following items and correspondence received:

- Rick Smith and several other local planning board chairs met with Phil Blair to brief him on community issues.
- Pardee's Savannah Terraces project was withdrawn from the Planning Commission agenda.
- Hilton Gardens is moving forward with their project as it was approved by the Board.
- Pardee is still marketing three industrial lots.
- Received a letter from the Miramar Ranch North Planning Committee (MRNPC) regarding traffic generation for the Scripps Northridge Industrial Park. The MRNPC is concerned that as the project builds out, the ADT ceiling imposed by the City will be exceeded. Upon a motion by Robert Frost and a second by Marian Pedrin, the Board voted unanimously to send a letter to the City expressing the Planning Groups support for maintenance of the current ADT thresholds.
- The tot lot is currently going through the bid process.

#### **POLICE REPORT**

Officer Lennon provided the Planning Group with a crime report for the month. He also reported that a public meeting with Chief Bejarano was scheduled for November 2<sup>nd</sup> at

6:00 p.m. at the Ranch Peñasquitos library. All members of the public are invited to attend this meeting.

### **REPORT FROM COUNCIL DISTRICT FIVE**

Sharon Tatel from the Council District Five office reported on the activities of newly appointed Councilmember Phil Blair. She provided Planning Group members with a letter from Councilmember Blair detailing recent district accomplishments and a press release regarding Blair's support for a proposed anti drag racing strategy.

### **COMMITTEE REPORTS**

#### ***A. Miramar Flight Operations***

1. Barbara Baker reported that the recent air show was a big success. She also noted that the marines are going to hold several public scoping meetings in the near future at which the marines will receive public input regarding the V-22 Osprey and issues that should be studied in their EIS. The V-22 Osprey will take the place of the CH-46. It is likely that these new aircraft will come to San Diego some time next year. To date there are still some safety concerns with the V-22.

#### ***A. Mayoral Candidate Dick Murphy***

Judge Murphy explained that San Diego is at a crossroad, facing many critical issues related to growth, the environment, and safety. He emphasized that San Diego needs a leader who is independent of special interests, and that he is that man.. After a question and answer period, Judge Murphy again thanked the Planning Group for inviting him to the meeting and encouraged people to vote for him on November 7<sup>th</sup>.
