Call to Order: 7:00p.m.

Agenda Additions: Guy Preuss made request to change Carter Reese action item to an informational item. Wayne English moved motion to change to informational item. Second by Michelle Krug, motion approved unanimously. Guy Preuss, stated that he has not received agenda or minutes from the City for two months.
