Presented by Rick Clark, video presentation was shown, stated that to meet needs of community the plant able retaining wall was moved, which increased open space. Discussion ensued regarding unresolved problems, questions not answered from previous meeting held with the community. The emails did not resolve questions from SPHCPG/community. Cul de Sac width, open space requirements, reducing the project by one house were some of the concerns discussed at length. Many residents of the community were present.

Nathan Beltz requested analysis for deviations from the standards in from an attorney.

Richard Lujan, inquired if the cul de sac would have a red curb to prevent parking. Rick Clark, responded "yes" to prevent parking.

Miles Pomeroy, stated pg 2 of 5 in emails-Engineer approves not PDP, engineer has authority to change code.

Calvin Martin clarified that an Attorney's interpretation was previously requested, issues have not been addressed. He addressed concerns with use of the word shall vs. may regarding minimum turning radius for cul de sacs. In addition, one unit should be moved and/or eliminated to meet the standard cul de sac width vs. being allowed a deviation.

Guy Preuss, we should have the form in appendix VIII "Deviation from Standards" pg 117 design standards for cul de sacs, geometric designs, pg 118, pg 120, pg 121, pg 122, pg 123, pg 129 appendix.

Motion #6-Moved by Guy Preuss, table Doti Point project t#1481 until January 13, 2009 so a copy of the Deviation from Standards form, Street Design Manual Appendix VII as filled out by the City Engineer or Asst. City Engineer, explaining the rational for granting the deviation can be presented to the SPHCPG. Second by Nathan Beltz. Motion carries by 10-0.

Mile Pomeroy, It's a technical matter not a legal matter. This project will go before the PCP again on January 22, 2009
