### COMMUNITY NOTIFICATION OF HIGH-RISK SEX OFFENDER

(San Diego) The San Diego Police Department and the San Diego Regional Sexual Assault Felony Enforcement (SAFE) Task Force announce the presence of a high-risk sex offender in downtown San Diego.

Douglas Ernest Badger, a convicted sex offender, was released from Atascadero State Hospital and is not on parole or probation. Badger was convicted of multiple sex offenses and other related offenses to include kidnapping, oral copulation, oral copulation in concert with force, conspiracy to commit a crime, grand theft, violation of parole, fraud by wire, and assault with a deadly weapon.

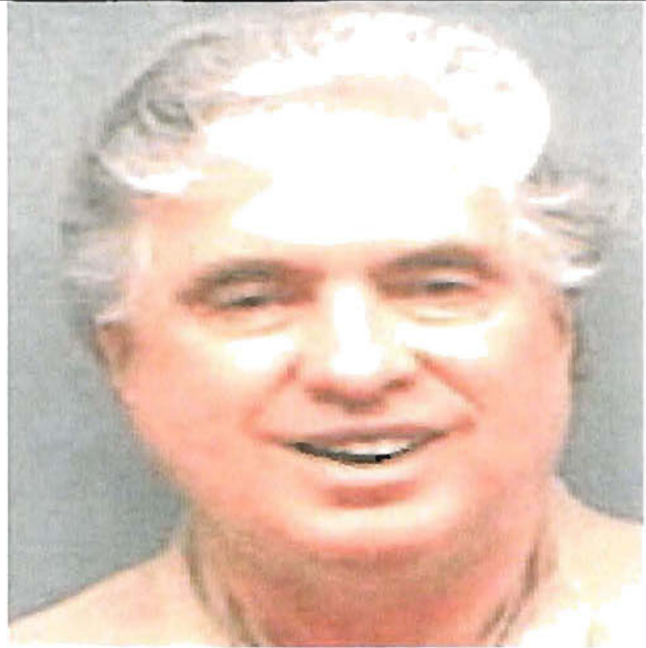
Badger, 64, is not wanted by the San Diego Police Department. This information is being provided for citizen safety in accordance with Penal Code Section 290 and the San Diego County Regional Sex Offender Management Committee (SOMC) protocol. The purpose of this release is to inform the public of the presence of high-risk sex offenders living in their communities. Badger's current residence is in a trailer at Donovan State Prison. Badger's placement in the downtown area is temporary because of some emergency repairs being done to his trailer. It is anticipated that the repairs will be completed in the next 24 hours. While Badger is in the downtown area, he will be monitored around the clock.

At this time, Badger has registered as a sex offender with the San Diego County Sheriff's Department and is in compliance with his sex offender requirements.

**BADGER** is a convicted sex offender recently released from Atascadero State Hospital. The San Diego Police Department considers **BADGER** a High Risk Sex Offender based on his past criminal background. He is under around-the-clock supervision by Liberty Healthcare in addition to wearing a GPS ankle bracelet so that his whereabouts can be tracked at all times.

**BADGER** is NOT wanted by the San Diego Police Department. **BADGER** is currently in compliance with his sex offender registration requirements.

**BADGER's** past criminal history includes multiple sex offenses:

- Kidnapping
- Oral copulation
- Oral copulation in concert with force
- Conspiracy to commit a crime
- Grand theft
- Violation of parole
- Fraud by wire
- Assault To Commit Rape
- Assault With A Deadly Weapon

**BADGER's** sex related offenses involved juvenile and adult males and female victims, 16 years of age and older.
