La Mesa PD Investigators Looking for Female Suspect Involved In Armed Robbery

Release Date: July 3, 2007

San Diego County Crime Stoppers is joining forces with the La Mesa Police Department to help identify and apprehend a female suspect wanted in connection with an armed robbery at a local business.

On June 20, 2007, at approximately 3:10 p.m., an unidentified female walked behind the counter of the Check 'N Go located at 5638 Lake Murray Blvd. in La Mesa and pulled a handgun from her waistband. The female suspect pointed the gun at the clerk and demanded cash. The suspect and the victim started putting money from the cash drawers into the suspect's purse. The suspect then fled the store and got into the passenger seat of a black, newer model Dodge Charger or Chrysler 300. The vehicle was last seen westbound on Lake Murray Blvd.

The suspect is described as a light skinned black female between 25-30 years old. She weighs about 180 lbs and has black hair and brown eyes. She is also described as having discolored teeth or may have had something on her teeth, She was wearing a grey hooded sweatshirt, dark pants, white shoes and white sunglasses.

The suspect's vehicle is described as a black, newer Dodge Charger or Chrysler 300. It has tinted windows and large chrome wheels.

La Mesa PD detectives are asking anyone with information on the identity and/or location of this suspect to call the **Crime Stoppers** anonymous toll-free tip line at **(888) 580-TIPS**. Crime Stoppers is offering up to a \$1,000 reward to anyone with information that leads to the arrest of the suspect.

For information leading to an arrest, you could receive up to a \$1,000 reward and remain anonymous.
