Suspect in Assault with a Deadly Weapon Case Caught on Surveillance Video

Up to a \$1,000 Reward

Release Date: December 17, 2008

San Diego County Crime Stoppers is joining forces with San Diego Police Department Mid City detectives to identify and locate two suspects wanted for assault with a deadly weapon.

Detectives said on November 15, 2008, at about 1:20 a.m., three victims, a husband and wife and their male friend, were at the "Mad Dogs" bar at 7123 El Cajon Blvd. in San Diego. The suspect (an unknown Black male) was singing karaoke at the same bar. For no known reason, the suspect walked over to the male victim (husband) and punched him several times in the face. The fight was immediately broken up and the suspect, along with a second suspect (a White male who was with the Black male) were escorted out of the bar. The victim, his wife, and their male friend decided to leave as well. As the three victims were walking home from the bar, the same two suspects walked up to the three victims. Words were exchanged and a fight between all four males erupted. When the male victim (husband) was knocked to the ground, his wife ran to his aid. The white male suspect knocked the female victim to the ground and proceeded to kick her multiple times in the head. The two suspects were last seen leaving the area in a black Honda Accord.

The victims (husband and wife) were both transported to a local hospital for treatment. The wife suffered a broken nose and a concussion. The husband suffered a fracture to his face and needed multiple stitches above his right eye. The third victim (their male friend) sustained minor injuries that did not require hospitalization.

Suspect Description:

Suspect #1) Black male, about 25-30 years old, 5'7" -5'9", about 150-170 lbs., with black hair and brown eyes. He was wearing a black shirt with a Cadillac symbol on the front and blue jeans. (This suspect doesn't appear in the video).

Suspect #2) White male, about 23-26 years old, 5'8" -5'11" tall, about 160-180 lbs., with brown hair and brown eyes. He was wearing a grey shirt, blue jeans, and a black sweatshirt (this suspect appears in the video).
