During the week of October 11-15, **San Diego County Crime Stoppers** will partner with local, state, and federal agencies to profile more than 50 wanted sex offenders who are thought to be in the San Diego County area. The goal of the **Fugitive Sex Offender Round-Up** is to locate, apprehend, and prosecute convicted sex offenders who are out of compliance with probation, parole, have failed to register as a sex offender, or currently wanted on new charges.

On the next two pages, 10 suspects are profiled. Crime Stoppers is asking the public for information that will help law enforcement locate these suspects. While it is impossible to predict an individual's future actions, two suspects are highlighted as the most wanted of this list. **Richard Wallace** and **Michael Anthony Marquez** are of particular concern to our law enforcement partners. Wallace is wanted by State Parole Agents for violating the conditions of his parole. His prior conviction is sexual battery. Marquez is wanted by State Parole Agents for violating the conditions of his parole. Marquez's conviction offense is rape with force and violence—a gang rape.

Historically, the public has been very helpful in providing information on the location of fugitives profiled in the media to Crime Stoppers. In 2009, 21 fugitives were apprehended with the help of tips to Crime Stoppers. The public is urged to come forward with information on these suspects as soon as possible.

Crime Stoppers will pay rewards of up to \$1,000 for information that leads to a felony arrest. Crime Stoppers' anonymous tip line number is (888) 580-8477. Anonymous email and text messages can be sent in via www.sdcrimestoppers.com.

The qualification of any person(s) for the reward and the amount of the reward for any person(s) so qualifying will be determined by San Diego County Crime Stoppers, Inc, in its sole discretion. Richard Wallace, DOB: 07/15/1981—**Most Wanted**

Description: White male, about 6' tall, approximately 210 lbs., with blonde hair, green eyes.

History: Wallace is wanted by State Parole Agents for violating the conditions of his parole. Wallace's conviction offense is sexual battery. Wallace is listed as a transient in San Diego.



Michael Anthony Marquez, DOB: 11/11/1967 —**Most Wanted**

Description: Hispanic male, about 5'9" tall, approximately 180 lbs., with black hair, brown eyes.

History: Marquez is wanted by State Parole Agents for violating the conditions of his parole. Marquez's conviction offense is rape with force and violence (gang rape.) Marquez is listed as a transient in San Diego.



Jose Castro, DOB: 05/03/1963

Description: Hispanic male, about 6' tall, approx. 180 lbs., with black hair, brown eyes.

History: Castro is wanted by State Parole Agents for violating the conditions of his parole. Castro's conviction offense is two counts of lewd and lascivious acts with a child under the age of 14. Castro is listed as a transient in San Diego.



Eric Earl Cole, DOB: 12/08/1963

Description: White male, about 6'1" tall, approximately 160 lbs., with brown hair, blue eyes.

History: Cole is wanted by State Parole Agents for violating the conditions of his parole. Cole's conviction offense is assault to commit rape and annoy/molest children. Cole is listed as a transient in San Diego.



Wayne Craig, DOB: 01/27/1981

Description: White male, about 6'4" tall, approx. 235 lbs., with brown hair, brown eyes.

History: Craig is wanted by State Parole Agents for violating the conditions of his parole. Craig's conviction offense is sexual contact with a minor and giving harmful matter to minor. Craig is listed as a transient in National City, El Cajon, and Lakeside.



Gary Crall, DOB: 08/19/1969

Description: White male, about 6'1" tall, approximately 190 lbs., with brown hair, blue eyes.

History: Crall is wanted by State Parole Agents for violating the conditions of his parole. Crall's conviction offense is criminal sexual contact with a minor. Crall is listed as a transient in San Diego.



Robert Froelich, DOB: 09/24/1966

Description: White male, about 5'6" tall, approximately 140 lbs., with brown hair, blue eyes.

History: Froelich is wanted by State Parole Agents for violating the conditions of his parole. Froelich's conviction offense is child molesting. Froelich is listed as a transient in San Diego.



Edgardo Gracia, DOB: 07/03/1982

Description: Hispanic male, about 5'9" tall, approx. 185 lbs., with brown hair, brown eyes.

History: Gracia is wanted by State Parole Agents for violating the conditions of his parole. Gracia's conviction offense is lewd and lascivious acts with a child under the age of 14. Gracia is listed as a transient in Chula Vista and San Diego.



Hyme Martinez, DOB: 01/20/1968

Description: Hispanic male, about 5'8" tall, approx. 150 lbs., with brown hair, green eyes.

History: Martinez is wanted by State Parole Agents for violating the conditions of his parole. Martinez's conviction offense is indecent exposure. Martinez is listed as a transient in Chula Vista and San Diego.



Michael Wagner, DOB: 01/24/1960

Description: Black male, about 6'2" tall, approximately 160 lbs., with black hair, brown eyes.

History: Wagner is wanted by the San Diego Police Department for violating the conditions of his sex registration requirements and for two outstanding sexual assault charges. Wagner's conviction offense is lewd and lascivious acts with a child.
