During the week of October 11-15, **San Diego County Crime Stoppers** will partner with local, state, and federal agencies to profile more than 50 wanted sex offenders who are thought to be in the San Diego County area. The goal of the **Fugitive Sex Offender Round-Up** is to locate, apprehend, and prosecute convicted sex offenders who are out of compliance with probation, parole, have failed to register as a sex offender, or currently wanted on new charges.

On the next two pages, 10 suspects are profiled. Crime Stoppers is asking the public for information that will help law enforcement locate these suspects. While it is impossible to predict an individual's future actions, two suspects are highlighted as the most wanted of this list. **Robert Eugene Sharber** and **Biliulfo Luna** are of particular concern to our law enforcement partners. Sharber is wanted by the San Diego Police Department for violating the conditions of his sex registration requirements. Sharber's conviction offense is attempted oral copulation by force. Luna is wanted by State Parole Agents for violating the conditions of his parole. Luna's conviction offense is lewd and lascivious acts with a child under the age of 14 with force and violence. Luna is listed as a transient in San Diego.

Historically, the public has been very helpful in providing information on the location of fugitives profiled in the media to Crime Stoppers. Last month alone, 4 fugitive sex offenders were apprehended with the help of tips to Crime Stoppers. The public is urged to come forward with information on these suspects as soon as possible.

Crime Stoppers will pay rewards of up to \$1,000 for information that leads to a felony arrest. Crime Stoppers' anonymous tip line number is (888) 580-8477. Anonymous email and text messages can be sent in via www.sdcrimestoppers.com.

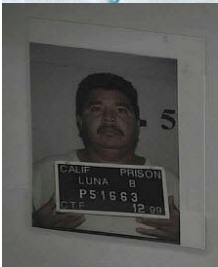

Robert Eugene Sharber, DOB: 08/23/1954—**Most Wanted**

Description: Black male, about 6'4" tall, approx. 210 lbs., with black hair and brown eyes.

History: Sharber is wanted by the San Diego Police Department for violating the conditions of his sex registration requirements. Sharber's conviction offense is attempted oral copulation by force.



Biliulfo Luna, DOB: 07/06/1962—**Most Wanted**

Description: Hispanic male, about 5'7" tall, approx. 220 lbs., with brown hair and brown eyes.

History: Luna is wanted by State Parole Agents for violating the conditions of his parole. Luna's conviction offense is lewd and lascivious acts with a child under the age of 14 with force and violence. Luna is listed as a transient in San Diego.



Donald Coffman, DOB: 02/01/1924

Description: White male, about 5'11" tall, approx. 200 lbs., with brown hair, brown eyes.

History: Coffman is wanted by State Parole Agents for violating the conditions of his parole. Coffman's conviction offense is kidnapping, rape, and murder. Coffman is listed as a transient and known to frequent the area of El Cajon in San Diego.



Jorge Cortez, DOB: 03/06/1952

Description: Hispanic male, about 5'6" tall, approx. 140 lbs., with black hair and brown eyes.

History: Cortez is wanted by State Parole Agents for violating the conditions of his parole. Cortez's conviction offense is lewd and lascivious acts with a child under the age of 14. Cortez is known to frequent the area of Sherman Heights in San Diego.



Raul Esquivel (aka Sam Lara), DOB: 06/07/1962

Description: Hispanic male, about 5'3" tall, approx. 135 lbs., with black hair and brown eyes.

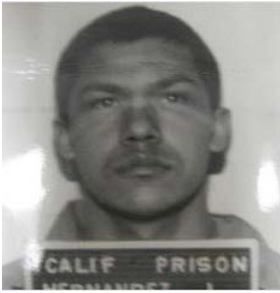
History: Esquivel is wanted by State Parole Agents for violating the conditions of his parole. Esquivel's conviction offense is lewd and lascivious acts with a child under the age of 14. Esquivel is known to frequent the areas of Escondido and Oceanside in San Diego.



Richard Irwin Files, DOB: 04/19/1959

Description: White male, about 5'10 tall, approx. 160 lbs., with brown/gray hair and blue eyes.

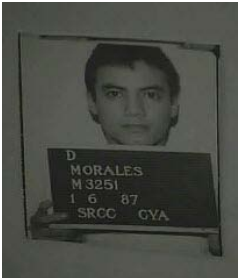
History: Files is wanted by the San Diego Police Department for violating the conditions of his sex registration requirements. Files' conviction offense is possession of obscene matter depicting children in sexual conduct.



Jose Hernandez, DOB: 11/10/1969

Description: Hispanic male, about 5'7" tall, approx. 150 lbs., with black hair and brown eyes.

History: Hernandez is wanted by State Parole Agents for violating the conditions of his parole. Hernandez's conviction offense is lewd and lascivious acts with a child under the age of 14. Hernandez is known to frequent the area of Chula Vista in San Diego.



Daniel Morales, DOB: 12/28/1966

Description: Hispanic male, about 5'3" tall, approx. 115 lbs., with black hair and brown eyes.

History: Morales is wanted by State Parole Agents for violating the conditions of his parole. Morales' conviction offense is lewd and lascivious acts with a child under the age of 14. Morales is known to frequent the area of Chula Vista in San Diego.



Tammy Dee Morin, DOB: 09/28/1966

Description: White female, about 5'1" tall, approx. 150 lbs., with brown hair and green eyes.

History: Morin is wanted by the San Diego Police Department for violating the conditions of her sex registration requirements. Morin's conviction offense is indecent exposure.



Randolph Wheeler, DOB: 11/19/1958

Description: Black male, about 5'3" tall, approx. 175 lbs., with black hair and brown eyes.

History: Wheeler is wanted by State Parole Agents for violating the conditions of his parole. Wheeler's conviction offense is forcible lewd act on a child and two counts of sexual battery. Wheeler is listed as a transient in San Diego.
