# VII. STAFF REPORT

#### A. Stadium Manager Mike McSweeney

Monster Jam show was sold out by 3pm it was a great turn out better than last years. Supercross is different than Monster Jam the audience has young adults and mostly adults. There is a lot more alcohol sales at Supercross vs. the Monster Jam in which it may be one parent with several children ages 8-12. Supercross opens the doors at 12:30pm for the prequalifying events. Jeff mentioned if there is a parking cost for these events, absolutely it is \$15 to park. Of all things equal looks like we will probably sell out Supercross. In terms of dirt events this is it, there are only two dirt events. The dirt show events are unique to the facility

because it is so big we need to have the dirt stored for them. Question regarding the X Games why these are not held here. The X Games have been held here at the stadium but this was a made for television event only not open to the public. We did not have a financial return as we thought we would on this type of event. It is best as a TV show.

Question has been asked how does the City help the community and tourism group to bring in more events to the stadium. We thought of bringing in a Drum & Bugle Competition beginning in the morning until the evening. This type of event would draw in around 300 High Schools, we did consider it even though the field would take a beating and it would cost \$100,000 to replace the sod. Unfortunately the schools took a vote and decided to go to Pasadena instead since they are looking to have a bed at night and do not go to a hotel.

We are currently bidding for the Gold Cup for next year. We have an agreement with SUM to produce a certain number of games in the year. There is a soccer game coming up on March 29<sup>th</sup> Mexico vs. Venezuela, there may possibly be another game in July. Have been talking with Creative Artists Industry known as CAI in the past had no relationship with soccer mostly movie stars, singers etc. It has developed relationships with some major teams and may be hosting a game here in July. Rudy asked what Security is like at these soccer games, do we need extra help? Soccer match crowds are pretty calm for the most it is a well behaved crowd. Even the alcohol sales are lower than the NFL games but these events are financially profitable. Ben asked Susan if there was a special food being brought in for the Venezuela crowd but they don't have anything planned. However, they do have the Mexico food covered. Not sure if they will have something special as they did for the Nebraska game. Rudy and members of the Board are would like to know if they may help out to continue the growth of events here. Mike said the RFP contracts are coming up, this area needs some assistance as it is much appreciated to keep the stadium running.

Non-event related items submitted to City Auditors responses on compliances and the letter from the Stadium Advisory Board involvement. The custodial RFP is coming up we had 15-20 companies here last week to bid on this contract. The AECom Contract continues to progress Luke attended our last meeting, we should receive the deliverables by the end of month or first week of March. This will show in terms how the stadium will perform in the next 10-15 years. When report is complete the Stadium Advisory Board would like to review it then Luke will relate the information to all regarding the business plan evaluation.

We presented the budget reductions to the Mayor's office on January 20<sup>th</sup> and indicated what the impact is for stadium operations reducing the Capital Improvement budget. Rudy asked even though we generate revenue how can we not have a Capital Improvement Budget? There is a FEMA/Homeland Security meeting on February 16<sup>th</sup> regarding the flood damage at the Stadium which was estimated around \$50,000 and to conclude this for a reimbursement.

The NFL gave the stadium "Kudos" for having a natural turf field, this was in the newspaper and according to Jeff we were Fourth place in the NFL and the players association there is only a few with natural turf. Mike mentioned we are usually rated in the top three. Every player in NFL prefers to play on natural turf.

Flooding was an item not on the budget as well as the OSHSA remedial project. These are items not accounted for and the Capital Improvement budget is used for these but will have to go without and figure how to deal with these.

Our current janitorial staff is Jani-King but the contract is up soon and will open for bidding. There was some controversy on the RFP Security according to Rudy since it was in the paper, why? There was several security companies the decision was not satisfactory to some therefore the article. We did not select the lower bid but went with the company offering better value. Sometime in the past there was overriding of other security companies and a lot of finger pointing. Another RFP coming up is with Ticketmaster, the Parking attendance RFP. The Bowl Association Agreement is up to be renewed this year. We are working on being ready for the upcoming season for NFL playing here whether it is a yes or no. If no NFL games we may come out with a profit at the end of the season.

Are you able to explain what happened at the Superbowl in Dallas. The extra seats were bleacher style type seats and the Fire Marshall looked at these and were not safe as they were installed. There was plenty of time to get seats installed properly but they waited until the last minute. These ticket holders were compensated three times the ticket value and are guaranteed a Superbowl ticket for next year. There may have also been some travel expense compensation? These seats were sold after the fact and were not considered permanent seating. Ben asked if the Superbowl was to come here to San Diego does the NFL takeover? We the City pretty much turn over the keys to them and they go about their business to setup for the Superbowl.
