A. Stadium Manager Mike McSweeney

Mike reported the wraps around the stadium look great it is one less area we have to paint thank you Ron for using the wraps and they add color to the areas.

Our Security agreement is out there the 24 hour security was awarded to Elite and the Event security was split and awarded to Staff Pro. Elite protested it so as of right now there is not much we can do we still have Elite as a bridging contract. We will continue as is until we receive some type of direction from Purchasing once it is all evaluated. It will eventually have to go to Council and get the final decision approved. It may be late September, mid October when this gets settled.

I would like to request for volunteers from the Advisory Board to be on the interview committee for the Building Maintenance Supervisor. This was the position that Steve was in at least part of the positions since it was split up to Building Operations and Field Operations. Looking for volunteers let me know after the meeting. This will be in the next couple of weeks don't know the date yet.

Minor report, a fan turned in some pieces of concrete which fell on them. Spalling is known s falling concrete which in a 45 year old building with 10,000 people in the stands jumping it will occur. The metal bracket construction over the years rusted and cement no longer adheres to

it. We contracted with Hazard Construction to remediate this they have already done the entire bowl. Price is still being examined from \$35k-\$400k but this was an emergency situation since it's a liability. When AECOM examined building all structural engineering two years ago building was rated at a level 3 which meant we need to look at this issue.

We have spent a lot more money than usual at beginning of fiscal year. We repaired bus gate due to the river overflow in had to be repaved. Also major repairs to jumbotron screen; some parts are obsolete and need to be fabricated but we upgraded it a bit.

Club Level repairs and painting as well as restored some floors were made since the Chargers and Aztecs were concerned for the patrons in the premium level areas. Some televisions were replaced in Clubs and put in larger 50" tv's getting rid of the tubes to increase the value of the Club level.

Past events were August 1st Chargers Night Practice, August 4th Fan Fest, and two Pre-season games. This coming weekend our staff guys will be tested on two weekends of back to back games, both Aztecs and Chargers football games on either Saturday or Sunday.

Looking at future event with MLS with Concacaf as we are a strong candidate for 2013 more than likely Mexico will be in the group of four teams coming here to play. CONVIS is actively working on getting these here to San Diego.

There is a local group Open Air Market which has a connection with Farmers Market organization. It's a start up event and would like to come out to the parking lot year round when weekends are available. Stadium events which are more profitable will prevail and they will be bumped out for that day or weekend. Our parking lot event revised fee schedule was based on AECOM's report for increasing rates. The asphalt space rental today is busy and continuing to grow. Today there is a Porsche Ride and Drive event which was invitational only. This concludes my report. Kim asked question about the Chargers vs Dallas game which she attended and noticed the delay during the replay on scoreboard why is that? Mike mentioned it may be due the trucks located out in the compound lot but they are always on top of this.
