All persons wishing to question, comment, object to, or be heard on such matters at the public hearings will be given an opportunity to appear and be so heard. The decision of the Agency is final. If you later desire to challenge actions of the Agency in connection with these actions, you could be limited to raising issues that you have raised at or before the public hearings, or written correspondence to the Agency at or prior to the public hearings.
