Plan Objectives: To resolve the claims to Rancho Penasquitos by the PQ Town Council and the Asian Pacific Islander community in a fair and equitable way.

One of the major issues before the San Diego City Redistricting Commission is how to resolve the Mira Mesa-Rancho Peñasquitos issue in a fair and equitable way. My proposal is to split the contested northern portion of the City of San Diego, giving Torrey Highlands and most of Rancho Peñasquitos to a new District 5, while giving Black Mountain Ranch and the highgrowth northern portion of PQ to a new District 7. To balance the population, the border of District 7 drops down to Tierrasanta (*continued next page*). The new District 5 is compact and contiguous, and the new District 7 preserves identified communities of interest (Poway Unified) to the greatest extent practicable.

Other changes include rebalancing District 5's population by uniting large portions of Clairemont with District 6, and combining the parcels of land east of the 805 that are identified as part of the UC Planning Area with District 5. The council district east of the 805 has been in control of those parcels for over 30 years, while the UC Planning Area's claim to those parcels is for a much shorter time.
