Plan Objectives: This can reduce arguments. It stops ignoring the major common interest of SDSU, Mission Bay, & the airport. Reduces splitting of neighborhoods. Everyone gives/gets something. Helps legal by making the Voting Rights Ast required 2 Hispanic & 1 Asian districts with highest overall seen percentages. Closely maintains Blacks%<(Census term) as before in D4. LGBT gets more of what they asked for in D3, even if not all. Creates a district for the areas most impacted by fires in the back county. Gives areas over looking Mission Bay a district. Keeps Mission Trails Regional Park in 1 district & SD River in 1 district. Reduces geographic separation of population north of National City in D8. Serra Mesa gets areas they asked for. Rancho Bernardo & Scripps Ranch stay together. Unites EACPC CPA & Oak Park neighborhood. Keeps UCSD common interest together. USD needs to be made whole by NDC, as the public cannot split Census blocks. That will alter numbers slightly but will not change highest & lowest deviations so it won't change the deviation range. The map does not reflect that North Bay Terrace & South Bay Terrace are separate neighborhoods per http://ederphoto.net/cnc/building/neighboorhoodcouncils/. This further reduces split neighborhoods.

Some minor oddities in districts are there to reduce deviations. If that is not desired, they could be changed. Maybe it would be a good idea to present one alternate map in case it is challenged based on deviation so the Commission would choose those changes for deviation court challenge rather than leave it to the courts & lawyers after the fact.

If you can find improves to this please alter, save, then post & share to "everyone" so we can do the best possible for our city.

This is my personal work. It does not reflect any votes on this specific map by EACPC or RPCC boards which I sit on. It includes ideas from others going back to March & up to the meeting of 8/18. I just worked them together to make as many happy as possible; increase, as I see it, the effectiveness of city districts; & the city as a whole.
