Dear District 2 residents,

On April 12th, Mayor Gloria released his proposed Fiscal Year 2025 Budget, which is focused on "Protecting Our Progress" and preserving the improvements the City has made on key issues like addressing homelessness and repairing infrastructure. Despite a challenging budget outlook, this \$5.65 billion plan seeks to maintain funding for priorities that are most important to residents.

The proposed budget features a \$104.6 million investment in road repair, which will allow the City to increase the miles of roads repaired from 60 miles budgeted in Fiscal Year 2024 to 75 miles in Fiscal Year 2025. Last week's Pavement Management Plan presentation to the City Council showed that District 2 has the lowest average Pavement Condition Index (PCI) score in the City, and this continued investment in street maintenance will bring our roads up to the quality District 2 residents expect and deserve.

The proposed budget does not make any substantive reductions in the budgets of public safety operations including the Police and Fire-Rescue Departments. It will also continue funding our efforts to address homelessness, including the creation of two important new shelter sites - a Safe Parking lot for those living in their vehicles at the H Barracks, and the largest proposed shelter in the City's history at the intersection of Kettner Blvd. and Vine St.

As a part of the budget process, the Mayor will present his proposed budget to the City Council on April 22nd at 1pm. Throughout the following weeks each City Department will present on the specific budget for their Department, allowing for public comment and discussion by the City Council. Performance Audit of the City's Street Maintenance Program and Update on the Pavement Management Plan (PMP):


On April 9th, the City Auditor's Office presented their findings from the
performance audit of the City's Street Maintenance Program. The first-ever
Pavement Management Plan, released in January 2024, was developed
concurrently with the Auditor's findings and addresses many of the Auditor's
recommendations to improve oversight and transparency of the Street
Maintenance Program. Council District 2 had the lowest average Pavement
Condition Index score (PCI) in all the City at 57, which falls in the "Fair"
category.

Streetlight Repairs in District 2:


 On November 1, 2023, the Transportation Department had 892 outstanding streetlight service requests in District 2. Thanks to the work of City staff and contractors, 441 streetlight service requests have been addressed since then, including 123 of them in the last month. Reducing the backlog in repairs and accelerating service has been the Transportation Department's priority. Repairs in parts of District 2 will continue through the month of April.
