• Michael Dwyer: PureWater construction continues northward on Clairemont Drive near the Clairemont Village shopping center. Several intersections with traffic signals have been converted to 4-way stops. Additionally, a Jersey Mike's will be opening in the Clairemont Square shopping center; the former Boston Market location on Balboa will be converted to a California Fish Grill.

# District 2 Council Report, Carrie Munson, Community Liaison, <a href="mailto:cmunson@sandiego.gov">cmunson@sandiego.gov</a>

- At the City Council meeting, amendments were presented to maximize 1st amendment rights, public safety and accessibility along with enforcement mechanisms for vendors on sidewalks, beaches and parks.
- A grand jury report was presented to the City Council regarding the poor state of street maintenance in San Diego. The report included recommendations for the city to follow.
- Upcoming Active Transportation and Infrastructure committee meeting will discuss the Safe Sidewalk Program and the Sidewalk Fee Holiday program.
- Upcoming ATI committee meeting will cover the year-end CIP report and a grand jury report on developer impact fees, which are paid to the city for developing infrastructure needed to support developments (e.g. roads, lights, parks, etc.)
- Public Safety Committee will approve body camera and digital evidence devices for police, 72 hour parking violators now must move their vehicles over 0.5 miles to be in compliance. A firearm procurement reform will be discussed.
- CTC is reviewing the Mayor's housing plan and is concerned that the Clairemont plan has not yet been released. ADUs are not required to have any setbacks (i.e. an ADU may be built alongside a property's boundary)
- Questions and concerns included:
  - Sources of funding for road repairs when State of California RMRA funding will dwindle

- Councilmember Campbell's lack of support for a new Clairemont library while other council districts have advocated for and received new libraries.
- Funding for homeless
- How to determine if items on the CCPG's CIP list would be implemented
- Status and implementation schedule for the City's Housing Action plan
- Concern that former Sheriff Bill Gore is not an appropriate candidate for the Ethics Commission by the Mayor's office

- o The California legislative session just ended; Governor Newsom has finished signing bills.
- Assemblymember Ward's bills included
  - Funding for Atmospheric River research and corresponding best practices for water management.
  - Funding at Community Colleges for non-credit courses which help people get specific job skills to boost their careers
- In spite of project State budget deficits, funding will go to the San Diego Fleet Science Center, San Diego fire rescue & protection and small business support
- Megan said her office could help with library funding
- Questions and concerns included:
  - Clairemont has not received any funding for improvements in FY 2024
  - Other neighborhoods received funding for new libraries but not Clairemont
  - Vaccine event to be held in East San Diego

- o Proposal is to reduce the required size to 12 members in order to make the required membership size be attainable
- o Size of the board could return to 16 members if the board should vote for a size change in the future.
- o Motion to reduce the size of the CCPG board to 12 members. Approved by Drew, Ian, Matt, Nicholas, Suzanne and Tarah; Declined by Billy

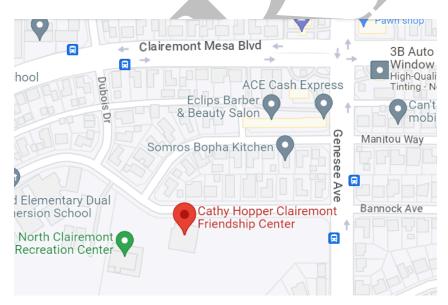
