POOL GUARD I - PART TIME POSITION

<u>PERFORMANCE TEST</u>: To qualify, you must submit an application and complete the performance test at a scheduled hiring event. Applicants must be **16 years old or older to apply**.

- Tread water for two minutes using your legs only
- Swim 20 yards, surface dive 7-10 ft. to retrieve a 10 lb object. Swim 20 yards on your back to return to the starting wall while holding the object with both hands and with your face out of the water. Climb out without using the ladder or stairs. All steps to be completed within 1 minute 40 seconds.
- Continuous 300 yard swim (12 lengths, no stopping).

POOL GUARD II - FULL TIME / PART TIME POSITION

<u>AGE (PART TIME)</u>: Applicants seeking part time employment must be 16 years old or older to apply.

<u>AGE (FULL TIME)</u>: Applicants seeking full time employment must be 18 years old or older to apply.
