## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT DESCRIPTION:** Contract between the City of San Diego (City) and the successful bidder (Contractor) to Invitation to Bid (ITB) # 10089987-24-G for the as-needed provision and delivery of fertilizer to the City's Parks and Recreation Department's Golf Division for as-needed maintenance of City-operated golf course facilities located at 11480 North Torrey Pines Road, San Diego, CA 92037 (Torrey Pines Golf Course); 2702 North Mission Bay Drive, San Diego, CA 92109 (Mission Bay Golf Course); and 2600 Golf Course Drive, San Diego, CA 92102 (Balboa Park Golf Course).

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Sections 15301 (Existing Facilities) and 15323 (Normal Operations of Facilities for Public Gatherings).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee.

## STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to CEQA Guidelines Section 15301 (Existing Facilities), which exempts the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; and Section 15323 (Normal Operations of Facilities for Public Gatherings) which exempts the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being

used for the same or similar kind of purpose. The exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked before or on the final date of the appeal.
