MOTION BY COMMISSIONER BOOMHOWER TO,

- RECOMMEND THE CITY COUNCIL TO APPROVE THE PROJECT PER STAFF'S
 AMENDED RECOMMENDATIONS, WITH THE ADDITION OF CONDITIONS OF
 APPROVAL PROHIBITING THE USE OF THE SITE FOR A PRE-K 12TH GRADE
 SCHOOL, LIMITING THE NUMBER OF WEEKLY WORSHIP SERVICES, MAKE THE
 SOUTH RETAINING WALL A VEGETATED RETAINING WALL, AND LIMITING THE
 PEAK HOUR OF USE OF THE CAMPUS TO THE TIMES THAT THE TRAFFIC ANALYSIS
 IS BASED ON.
- RECOMMEND THE CITY COUNCIL INCORPORATE THE CONDITIONS REQUESTED BY LANCE GRUCELA.
 - 6' CINDERBLOCK CONTIGUOUS WALL BETWEEN THE PROJECT AND ALL NEIGHBORING RESIDENTIAL PROPERTIES.
 - NO GATES OR ANY PEDESTRIAN OR VEHICULAR ACCESS TO SITE FROM NEIGHBORING RESIDENTIAL PROPERTIES.
 - FROM INCEPTION OF PROJECT THEIR OWN ARCHITECT ADMITTED THAT THIS WAS NECESSARY TO PROVIDE PROTECTION FOR ADJACENT RESIDENCES.
 - BASED ON RECENT DISCUSSIONS WITH CHURCH REPRESENTATIVES,
 THEY ARE APPARENTLY IN AGREEMENT SUCH A WALL IS NECESSARY
 - EIR ALTERNATIVE PROPOSES REMOVAL PROPOSES REMOVAL OF 37 PARKING SPOTS.
 - THESE 37 SPOTS SHOULD BE REMOVED FROM THE NE SECTION OF THE SITE BORDERING NEIGHBORING PROPERTIES TO MINIMIZE IMPACT ON THE FIRST 8 LOTS WHERE PARKING IS MUCH CLOSER TO PROPERTY LINES AND PAD HEIGHTS ARE SIMILAR.
 - o NO ADDITIONAL HEIGHT DEVIATION FOR ORNAMENTATION.

- ORNAMENTATION CAN REASONABLY BE INCORPORATED INTO ARCHITECTURAL ELEMENTS WHICH ALREADY SURPASS THE MAX HEIGHT AND REQUIRE DEVIATION.
- NO NIGHT OR WEEKEND WORK.
- RECOMMEND THE CITY COUNCIL CERTIFY ENVIRONMENTAL IMPACT REPORT (EIR) NO. 636444/SCH NO. 2021100394 AND ADOPT THE MITIGATION, MONITORING, AND REPORTING PROGRAM (MMRP).
- RECOMMEND THE CITY COUNCIL APPROVE THE GENERAL PLAN/COMMUNITY PLAN AMENDMENT NO. 2292367.
- RECOMMEND THE CITY COUNCIL APPROVE SITE DEVELOPMENT PERMIT NO. 2292338.
- RECOMMEND THE CITY COUNCIL APPROVE PLANNED DEVELOPMENT PERMIT NO. 2292339.
- RECOMMEND THE CITY COUNCIL APPROVE TENTATIVE MAP NO. 2490918 INCLUDING THE REVESTMENT OF ACCESS RIGHTS.
