SUBJECT: Calling Special Election to Fill Vacancy in Council District 6

#### <u>ISSUE</u>

Shall the Council call a special election to be held on Tuesday, April 17, 2001 for the purpose of filling a vacancy in the Office of Councilmember for Council District 6?

### BACKGROUND

On January 29, 2001, Councilmember Stallings submitted to the City Clerk her resignation from the City Council, effective immediately (attached).

Since there is over one year remaining in the term of office, City Charter Section 12 requires the Council to call a special election to be held in the district within ninety days of the date of the vacancy. If one candidate receives the majority of votes cast for all candidates in the special election, that candidate shall be deemed to be elected to the vacant office. If no candidate receives the majority of votes cast in the special election, a special run-off election must be held within forty-nine days of the first special election. The candidate elected at either the special election or at the special run-off election shall be declared elected for the unexpired term, and shall assume office at the time the City Council adopts the resolution declaring the results of the election.

#### RECOMMENDATION

The City Clerk is recommending that the City Council call for a special election to be held in Council District 6 on Tuesday, April 17, 2001. This is the earliest practical date available for the special election and is within the ninety day limit established by the Charter.

If a special run-off election is required, it would be held on June 5, 2001. The following schedule would apply:
