#### Item 5: Commissioner Comment

Commissioner Potter commented on the recent open house hosted by Devaney Pate Morris & Cameron at the firm's new office located in downtown San Diego.

Commissioner Voorakkara asked Commissioner Potter about his recent efforts with respect to the lobbying of City staff who serve as Hearing Officers for certain types of land use matters. Commissioner Potter explained that when he reviewed a Fact Sheet recently issued by Commission staff, he realized that these Hearing Officers are not covered by the City's

lobbying laws. As a result, he asked Executive Director Fulhorst to follow-up with Bob Vacchi, the Director of the City's Development Services Department. According to Ms. Fulhorst, Mr. Vacchi advised her that Hearing Officers are not allowed to discuss a pending matter with any interested party (including lobbyists) outside of a hearing in light of due process considerations. In response to a request from Commissioner Potter, Mr. Vacchi recently updated the department's website to address this prohibition. Ms. Fulhorst thanked Commissioner Potter for his efforts, which alleviated the need for the Commission to consider expanding the City's lobbying laws to include disclosure of lobbying contacts with Hearing Officers.

#### Item 6: Executive Director Comment

Ms. Fulhorst reported that staff will be working with the City's Department of Information Technology to develop an online complaint form which will make it easier and more efficient for individuals to submit complaints. In addition, staff will be working with the City's Communications Department on the development of a website video that will provide a general overview of the laws within the jurisdiction of the Commission.
