#### Item 10: Proposed Amendments to Election Campaign Control Ordinance

John Nienstedt with Competitive Edge provided public comment concerning the impact of advertising disclaimer requirements on surveys conducted by professional pollsters.

In response to Mr. Nienstedt's comments, Ms. Fulhorst explained that the proposed amendments to ECCO would eliminate the current definition of "mass telephone communications" which includes polling and would rely on the state's definition instead. According to state law, calls made to 500 or more households for the purpose of supporting or opposing a candidate must include a "paid for by" disclosure. She explained that it would be up to the Commission to evaluate the facts and determine whether a particular call was made for purposes of advocacy.

In addition to the laws governing telephone calls, Ms. Fulhorst pointed out that the rules governing electioneering communications would require any communication, including a telephone poll, conducted within 90 days of an election to include a "paid for by" disclosure if it mentions a City candidate. Ms. Fulhorst invited Mr. Neinstedt to communicate with Commission staff concerning possible amendments he might like to propose to the electioneering communication rules.

Commissioner Kosmo asked if a polling call to 450 people would require a disclosure under the new state law and Ms. Fulhorst confirmed that it would not because it would fall under the 500-call threshold.

Commissioner Baber asked about the timeline for implementation of the proposed amendments. Ms. Fulhorst explained that the City Council Rules Committee will consider the proposed amendments in April; if approved, they will be submitted to the full City Council in late April or early May, concurrent with a review by the City Attorney's Office. Following a second reading two weeks later and then a 30 day waiting period, the new laws should go into effect in mid-June, which is ideal timing for the November general election.
