Item 6: Executive Director Comment

In response to a request from Commissioner Potter, Ms. Fulhorst reported on the questions she answered concerning state legislation at the end of the Fair Political Practices Commission meeting that was held in San Diego on May 16, 2019.

In response to a request from Commissioner Voorakkara, Ms. Fulhorst explained the changes made by the City Council Rules Committee to the Commission's proposed amendments concerning lobbyist disclosure of activity expenses. Specifically, she explained that Council President Gomez suggested the addition of three additional dollar amount ranges. She added that the full City Council will review the proposed amendments in early July 2019.

Finally, Ms. Fulhorst advised the Commissioners that the Secretary of State, the FPPC, and the Political Attorneys Association are jointly pursuing legislation to extend the implementation date of the Cal-Access Replacement System from December 2019 to February 2021 in order to avoid the glitches associated with a new system in the midst of the 2020 election cycle.
