Every office will be trained by early March 2023. She said that staff will also begin offering candidate trainings later this year, as 2024 municipal campaigns are now under way.

The Executive Director also noted that new campaign contribution limits for City candidates will be announced during the first quarter of 2023.

She also noted that the Commission is currently scheduled to return to inperson monthly meetings in March 2023. The City Council is not expected to extend COVID emergency resolutions past February 10, 2023, which provide the legal basis for fully remote Commission meetings. The Commission's next meeting, which is scheduled for February 9, 2023, will be a virtual meeting on Zoom, as that date is included within the Council's current resolution.
