

Minutes for the Meeting of Thursday, August 17, 2023

Item 1: Call to Order

The Commission Chair called the meeting to order at 2:00 p.m.

Item 2: Roll Call

Due to the fact the terms of office for the Chair and Vice Chair expired on June 30, 2023, in accordance with the San Diego Municipal Code, agenda Item 8 was heard first. This enabled the Chair to conduct the rest of the meeting.

Item 8: Election of Ethics Commission Chair and Vice Chair for Fiscal Year 2024

The Ad Hoc Committee, made up of Commissioner Voorakkara and Commissioner Cooper, met to consider and recommend nominees to serve as the Commission's next Chair and Vice Chair, for Fiscal Year 2024. Commissioner Voorakkara announced that the Ad Hoc committee made the following nominations:

Item 5: Commissioner Comment

Commissioner Cooper thanked the Commission for accommodating his request to change the meeting time.

Commissioner Slack thanked Chair Sanchez and Vice Chair Cooper for agreeing to continue to serve in their respective roles.

As this was the last meeting for Commissioner Voorakkara, who has served two full terms, Chair Sanchez thanked him for his extended service on the Commission.

Item 6: Executive Director Comment

The Executive Director made the following announcements:

(1) The Mayor's Office said it is sending a memo to Councilmembers and the City Attorney to request nominations for the three open seats on the sevenmember Ethics Commission (including the seat soon to be vacated by Commissioner Voorakkara). At least two of the open seats must be filled by attorneys in good standing with the State Bar of California. The Executive Director expressed her hope that appointments would be made as soon as possible: the Commission needs at least four members to be present for a quorum, at least four members to take actions, and at least five members to approve settlements. As the City Council is on Legislative Recess, it is unclear when appointments will be made.

- (2) The random drawing to select the 2022 campaign committees that will be subject to an Ethics Commission audit will be held at the Commission's next meeting, on September 14, 2023.
- (3) The Ethics Commission concluded its 2023 Fiscal Year on June 30, 2023, coming in under budget, as it has done for many years.
- (4) The Executive Director has been making presentations to numerous organizations about the Ethics Commission, campaign finance and ethics laws, and the operations of the office. This is part of her continued outreach to heighten awareness of the office and the roles it plays. She recently gave a presentation to the City of San Diego's interns. On August 18, 2023, the Executive Director and Education Program Manager Ryan O'Connor are speaking to the California Political Treasurers Association. In September 2023, the Executive Director will be part of a panel with representatives of two other Ethics Commissions at the California Political Attorneys Association conference.

The Executive Director also thanked Commissioner Voorakkara for his long service on the Commission, and for the help he has provided to her throughout her time in this role.

Item 7: General Counsel Comment

General Counsel Christina Cameron thanked the Commissioners for their flexibility in accommodating her need to attend the meeting remotely. She explained that the Brown Act provisions regarding circumstances in which a Commission member may attend remotely do not apply to staff.

The General Counsel also thanked Commissioner Voorakkara for his service on the Commission.
