Here is the process for renaming City of San Diego Parks.

First step is to gain support from your local Recreation Council (Advisory Board for local parks). Del Mar Mesa Park is in the jurisdictional boundary of Ocean Air's Recreation Council. Your staff contact is Kevin Wiggins kwiggins@sanidiego.gov

Once the Recreation Council supports the proposal through formal action, it can be taken to the Community Parks I Area Committee for support. I am the P&R staff representative for CP-1 Area Committee.

The final step will take the proposal to re-name the park to the Park & Recreation Board for approval. Once you have the support from Rec Council and Area Committee, I can assist you at the P&R Board level. See Park Board Policy 1001 (attached).
