### **CHAIRPERSON'S REPORT**

Dennis Otsuji reported that at the February 16, 2017 Park and Recreation Board meeting, Linda Vista's Morley Green Mini Park was re-named to John Baca Park; the Tecolote Canyon Natural Park Master Plan was approved; and Sea World's Electric Eel Attraction (new ride) was approved.

### STAFF REPORT

Mike Rodrigues, CPI Area Representative, provided an update on Park and Recreation Department water usage due to drought conditions. Recent rains have allowed a significant cut back in irrigation schedules and many of the turf areas have recovered. However, water use restrictions are still in effect; Mike provided an update on many parks currently under construction including Mira Mesa Park expansion, Torrey Meadows, Del Sur and Del Mar Mesa. Mike briefly discussed the draft City Council Policy for naming City assets which was sent out to all Recreation Council Chairs. The objective is to provide the City with a consistent method of naming assets; The renaming of the Carmel Valley Riprian Enhancement (CVREP) Trail to "The Marvin Gerst Tail" was approved at February's Park and Recreation Board meeting.

101. Request to rename the Del Mar Mesa Neighborhood Park (currently under construction) to "Elizabeth S. Rabbitt Neighborhood Park" – presented by Dan O'Rourke

Dan O'Rourke, neighbor and friend of Elizabeth Rabbitt, presented a packet and provided a brief background on who Elizabeth Rabbitt is and why she is so deserving of having the new park named after her. Ocean Air Recreation Council approved the re-naming recommendation and the majority of the Del Mar Mesa Community supports it.

She has been in contact with Steve Palle, District Manager, and some of the repairs are in the works. Pat also shared concerns by residents regarding the renaming of the new playground at Saratoga Shoreline Park.

Sue Evans announced that the Doyle Community Park playground project is out to bid.
