This letter is in response to your application submitted on January 6, 2011, in which your firm requested the City of San Diego (City) to evaluate and approve PowerSeal Pipeline Products.

The City has completed the review of this application and determined that adequate data has been presented to approve the PowerSeal Pipeline products listed below:

- Repair Clamps Model 3121AS, 3122AS, 3123AS, 3131AS and 3132AS
- Universal Coupling PowerMax 3506, 3506LB and 3506AS
- Transition Coupling Model 3501 and 3501LB
- Flange Coupling Adapter Model 3521 and 3526
- Bronze Service Saddles Model 3401, 3403 and 3407
- Stainless Steel Tapping Sleeves Model 3480AS, 3490AS and 3490MJ
- Air Release Valve Combination Model 5403



- 2) PowerSeal Pipeline Products Corporation shall notify the City in advance of any changes in the products, ownership, or location of the manufacturing plant(s).
- 3) PowerSeal Pipeline Products Corporation shall provide application/installation procedures for the products to ensure the products meet the Standard Specifications for Public Works Construction (Greenbook) and the City's Whitebook 2012. The installer shall meet the specification conditions required for the proper installation of products as specified by PowerSeal Pipeline Products Corporation or any of PowerSeal Pipeline Products Corporations authorized suppliers.
- 4) Any unilateral action by PowerSeal Pipeline Products Corporation without prior consultation and agreement from the City regarding the above mentioned conditions and limitations shall constitute a breach of agreement resulting in the removal of PowerSeal Pipeline Products Corporation products from the City's Water Approved Materials List.
