The financial outlook for Fiscal Year 2014 (FY14) is more encouraging than San Diegans have seen in years. Our region's slow economic recovery provides the welcome opportunity to restore core city services which have been cut over the last five years. However, while the Mayor's proposed budget has some positive aspects, the budget somehow adds millions of new dollars and dozens of new positions without increasing neighborhood library or rec center hours. I am encouraging my colleagues to focus primarily on *core* neighborhood services in this critical rebuilding year and have recommended that the following budget revisions be made in the FY 14 budget:

Focus personnel additions on police, libraries, & park & rec: The proposed budget includes dozens of new city employees in areas such as the new "Civic and Urban Initiatives" program, administrative analysts, aides, and support staff for City TV. While I understand that all of these additions may provide some value I reiterate my support for core neighborhood services. I recommend that the Council only increase positions in the Library, Park & Rec, Police, Lifeguard and other departments.

**Implement managed competition:** San Diego voters passed managed competition overwhelmingly in 2006 and after years of delays this cost-saving, common-sense program was beginning to get off the ground last year. Unfortunately, that progress has stalled and budgeted savings from managed competition may not be realized in this fiscal year. It is my top budget priority to see managed competition move forward without delay, specifically street sweeping, PUD customer support, street and sidewalk maintenance, landfill operations and fleet maintenance for savings of \$4.1 million.

**Increase funding for facility maintenance:** Infrastructure funding, coupled with restoration of core neighborhood services, should be the City's priority as we begin to emerge from our recent economic troubles. Because San Diego likely has over \$1 billion in deferred infrastructure maintenance I am glad to see a slight increase in infrastructure funding for slurry sealing and repair to concrete streets. However, I would like to see increased funding of \$600,000 for police facilities. I would also like to see \$200,000 in additional maintenance on cultural facilities. This increased funding could come from efficiencies within Public Works-General Services Administration and facility functions.

**Restore overnight camping at Kumeyaay Lake Campground:** The City of San Diego of operated a campground in Mission Trails Regional Park until budget cuts closed the Kumeyaay Lake Campground to overnight camping in 2009. As the only public campground within the City, and because it is located close to our urban neighborhoods, Kumeyaay Lake provides a unique opportunity for San Diegans s to camp overnight. Although the Mayor proposed a restoration of that campground in the FY13 Mid-Year Budget Monitoring Report, the funding was pulled from the campground. I strongly support funding to restore overnight camping and the related rehabilitation of the Mission Trails Visitors Center in the FY14 budget.

With our economy improving as it currently is, it is imperative that city leaders come together and put our neighborhoods first.

# **City Council Approves the San Diego River Park Master Plan**

After almost 11 years, the San Diego City Council unanimously approved the San Diego River Park Master Plan on May 30, 2013.

The Master Plan, a policy document to guide future development along the 17.5 miles of the San Diego River, provides the vision and guidance to restore a relationship between the river and surrounding communities by creating a river-long park system. The vision for this park includes a contiguous river trail that stretches from Mission Trails Regional Park in the Navajo and Tierrasanta communities, to the Pacific Ocean at Ocean Beach. This trail will not only provide recreational opportunities for joggers and cyclists but will also provide educational and exploration opportunities for students and those who love the outdoors by incorporating interpretive signage and display boards with information about various parts of the river.

Upon passage of the plan, Scott thanked his colleagues for their support. "A park system along the San Diego River will increase recreation opportunities for our residents, preserve and enhance the river's natural resources, celebrate the river's rich cultural history, and will help to improve the quality of life in Mission Valley and other District 7 communities."

The Master Plan is the result of grassroots efforts begun by the San Diego River Park Alliance (2001) and the San Diego River Park Foundation working in partnership with the City of San Diego, community planning groups, business leaders, and advisory bodies. Their continued involvement will be important to its successful implementation.

# **Del Cerro Community Coffee: How Can We Help You?**

As your representative on the City Council, I believe that one of my greatest responsibilities is getting out into the community to hear from you directly. This is why I was excited to hold my first ever "Community Coffee" on May 28<sup>th</sup> in Del Cerro. Over 40 people from the San Carlos, Allied Gardens, and Del Cerro areas came to this coffee, and voiced their opinions on a wide range of issues. For two hours we spoke extensively about lane channelization, the city budget, road repairs, open space issues, weed abatement, as well as a variety of other community topics. Being able to talk with individuals directly is important, and I have already begun working on issues raised during the coffee.

I hope to see all of you at future Community Coffees, and look forward to hearing about issues import to you, your family, and your community. The next coffee will be held in Tierrasanta on Wednesday, July 10<sup>th</sup>.
