The City of San Diego Commission for Arts and Culture serves in an advisory capacity to the Mayor and City Council on promoting, encouraging and increasing support for the region's artistic and cultural assets, integrating arts and culture into community life and showcasing San Diego as an international tourist destination.

The Commission is composed of 15 volunteers appointed by the Mayor and is supported by a staff of professional arts administrators.

It is the purpose and intent of the City Council to establish a Commission for Arts and Culture to serve in an advisory capacity to the Mayor, City Council and City Manager on promoting, encouraging, and increasing support for the region's artistic and cultural assets, integrating arts and culture into community life and showcasing San Diego as an international tourist destination.

It is also the purpose and intent of the City Council to set forth the duties and functions of the Executive Director and staff that support the Commission for Arts and Culture, which include: developing, implementing, evaluating and/or recommending changes to public policy, legislation, programs, services and advocacy strategies; overseeing funding allocations in support of non-profit arts and culture organizations, artists, neighborhood arts programs, festivals, and artworks in public development; ensuring the inclusion of art in private development; managing artworks owned and controlled by the City; supporting cultural tourism and innovative arts and culture programming; and undertaking other initiatives that contribute to the quality of life, the economic vitality, and the vibrancy of San Diego.



Commissioners

Fifteen volunteers appointed by the Mayor compose the City of San Diego Commission for Arts and Culture. Commissioners represent a diversity of backgrounds and are selected from individual arts and culture patrons, artists, educators, the business and professional community, those with professional qualifications and experience or knowledge of a particular arts and culture field, and the general public.



Janet Konstantin Poutré, Chair

Janet Konstantin Poutré is the founder, owner and editor of Clairemont Community News, named Small Business of the Year for the 76th District by state Assembly member Lori Saldaña in 2009. She formerly served as president of the Clairemont Chamber of Commerce and as a long-time board member of the San Diego County Apartment Association. Poutré worked as a District Manager for Grantree Furniture and head of operations for K-Co Construction, employing robust skills in sales and marketing. Her talent for entrepreneurship and innovation led to a key role in the water conservation industry through the design and sale of an improved water meter for apartment and condominium communities. Her leadership in the creation and launch of AptBiz.com, a website for the owners and managers of apartment communities nationwide, resulted in programming that attracted significant investors and was featured in a forum by CONNECT, then a program of UC San Diego Extension. In 2001, Poutré was chosen as a counselor for a Vassar College program to teach entrepreneurship skills to teens. Poutré was born in New York City and raised on trips to museums, Broadway shows, and weekly piano lessons. She holds a B.A. in Art History from the State University of New York, College at Potsdam and, when not traveling to see her favorite band, Los Lobos, Poutré lives in Clairemont with her husband and their dogs.



Vernon Franck, Vice Chair

Vernon Franck is a professional land surveyor and owner of Metropolitan Mapping, a land surveying and mapping practice devoted to forward-thinking building projects that enhance the core metropolitan communities of San Diego. Franck has served on the boards of Sushi Performance and Visual Art (President) and Space 4 Art (Treasurer). He is a member of the Commission's Public Art Committee (2009-present) and has served on public art selection panels for the Bayside Fire Station (City of San Diego) and the Wrap Project (Port of San Diego). He has also served on the North Park Planning Committee and was Chair of their Urban Design/Project Review Subcommittee. He has been on advisory panels for the Museum of Contemporary Art San Diego's TNT event, the AlA's Orchids and Onions awards, the Barrio Logan/East Village Arts District and the Market Creek Arts District. Franck received a B.A. in Geography from San Diego State University (SDSU) and continued at SDSU as a graduate student in Urban Geography, City Planning and Environmental Design. He enjoys robust relationships with working artists of all persuasions and thoroughly enjoys the pursuit of arts and culture far and wide, high and low. He lives, works, walks, bikes, delivers kids, dines and shops in North Park.



Dajahn A. Blevins

Dajahn A. Blevins is a humble servant leader, a proud father, son, brother, educator and Behavior Modification Specialist using the arts, culture and creative nontraditional interventions to help bring about change. His battle cry is Kujichagulia meaning Self Determination and his tool is his creativity, love and passion that outweighs the doubt and self-hate encountered in his work to instigate change. His program is based on using art to be engineers for change. Mr. Blevins is a 1982 graduate of Texas College where he earned his B.S. in Social Sciences continuing his education at San Diego State University his focus in Sociology and Performing Arts. The more sociology taught him about the plight of his people the more his creativity was stirred to create tools to bring about change. In 1984, he created the B.L.A.C.K Club (believers in altruism culture & kinship) 1986 he established Urban Warriors Inc and declared war on negative vibration and low level energy, 1989 Dajahn earned the title of Mr. Black San Diego and began a journey of using his creativity to help to promote healthy active fit communities through edutainment and community mobilization. Urban Warriors became uniquely qualified through Dajahn leadership to provide the opportunity and environment for positive lifestyle change. His program A Challenge to Change AC2C provide prevention, intervention and ongoing support, as a Community Health Educator and San Diego City School Outreach Worker he incorporated education, health, social skills, culture and entertainment [Edu-tainment] programs like: Shule Ya Basura na Umoja (School of Foresight and Unity) Freedom Schools, Project ENABL (Education Now & Babies Later) Champions for Change healthy active fit project and the UPAKA Urban Performing and Kreative Arts center to name a few. In the evening, he is an Aubrey award-winning actor, singer dancer, director and playwright who has graced the stages of many theaters in San Diego, working with the likes of Loretta Devine and Lawrence Fishburne. Dajahn continues to use his talents as a producer, Artistic Director, performer, teacher and educator of health, wellness culture and fitness. He is the creator of the DABADOYA international youth entrepreneur mentoring project and the Kuumba Fest San Diego's longest running arts and culture celebration of its kind.



Ann Bossler

Ann Evons Bossler is the Director of Program Development for Price Philanthropies, an organization championing underserved youth and revitalizing the City Heights community. She is a grants officer for education and arts & culture within San Diego, and oversees the implementation of multiple educational programs which benefit local Title I students. Bossler previously facilitated the leadership development of Fortune 500 corporate clients at The Center for Creative Leadership, and was the Executive Director of the Coronado Response Group, a community program that fostered cooperation between the city, school district and community. She received her business degree from Emory University, her counseling credential/degree from the University of San Diego and her Ed.M. in administration, planning and social policy from Harvard University. Bossler is a native San Diegan who has travelled the world and believes there is no better place than San Diego. As a Commissioner, she hopes to continue creating opportunities for youth, and their families, to achieve their hopes, dreams and goals.



Michael Brown

Michael Brown is Associate Curator of European Art at the San Diego Museum of Art, having served previously form 2007-20013 in the New World curatorial department at the Denver Art Museum. He earned his Ph.D. in 2011 from New York University's Institute of Fine Arts with a dissertation on Spanish Colonial and Spanish portrait painting. Mr. Brown has taught as a visiting lecturer at the University of Colorado, Boulder, and University of Denver. He has published widely, contributing essays on Colonial portraiture to catalogues for Brooklyn Museum, Denver Art Museum, and Fomento Cultural Banamex, Mexico City. In 2015, he curated Divine Desire: Printmaking, Mythology, and Birth of the Baroque at The San Diego Museum of Art and authored it companion publication.



Tracy Dezenzo

Tracy Dezenzo's creative and inquisitive spirit has been a defining characteristic. As a teen and young adult, her free spirit led her to skip the traditional education route and pursue a more worldly and experiential one. Returning to traditional education in her 30's, she received a BA in fine art (photography) from UC San Diego and a B.S. in Graphic Design & Marketing from the Art Institute. As an award-winning graphic designer, she is grateful to have engaged with wonderful clients and employers, talented coworkers and inquisitive learners. Yet, some of the experiences Tracy has found most gratifying include preparing multiple design interns for work in creative fields, being a mentor/big sister to young women, in-house counselor to teenage substance abusers, singer/songwriter/guitar player for three pop/rock bands, and over ten years practicing karate. In addition, Tracy is Secretary of the Ocean Beach Planning Board (OBPB), Chair of the OBPB Transportation subcommittee, and Chair of a newly formed OBPB Public Outreach subcommittee, which she advocated for as a critical method to keep the Ocean Beach community engaged. In 2017 Tyler was appointed by Mayor Kevin Faulconer to serve on the City of San Diego's Commission for Arts and Culture. Tyler is active in the arts as a supporter, as well as occasional actor, director, and playwright. Gina M. Jackson

Gina M. Jackson, M.A., M.Ed. is an Adjunct Professor and Secondary Educator in San Diego, CA. She has a B.A. in Speech Communication/English and Theatre Performance minors from Southern Illinois University Edwardsville; an M.A. in African-American Studies/Literature-Theatre from Clark Atlanta University (Master's Thesis: African-American Theatre: An Aesthetic Analysis of Four Contemporary Theatre Companies); and an M.Ed. and Preliminary Administrative Services Credential from National University. Jackson was recently appointed to the Board of Advisors of the Atlanta Black Theatre Festival (ABTF). She also serves as a Board Director for the City of San Diego Horton Plaza Theatres Foundation, the County of San Diego Community Action Board, and a Coordinator for the San Diego Women's Foundation. Jackson is a member of Sigma Gamma Rho Sorority, Inc. and the National Council of Negro Women, Inc. She is an award-winning National Endowment for the Humanities Scholar, having researched and studied the Mississippi Delta and Duke Ellington. She is the Founder and Executive Artistic Director of Cultural Noire Performing Arts Company, and since 2015, the theatre has been a presenting partner of Project1VOICE of New York City. Jackson completed the Museum Studies Professional Studies Program at Northwestern University in December 2019. She has also completed Global Humanities programs at the University of Southern California (USC) and the University of California Berkeley.



Ben Meza

Ben Meza is an architect and principal with Architects Mosher Drew. He leads the Healthcare, Federal and zoological design studios and his clients include Sharp Healthcare, Kaiser Permanente, Children's Hospital, Naval Facilities Engineering Command, and San Diego Zoo Global. Beginning today, we commit to evaluating our role as a Commission, and pledge to change policies or procedures that contribute to systemic racism and further marginalization. We commit to being part of the solution, building bridges, equitably using our resources and leveraging our privilege as a commission of the City of San Diego in a just manner.

We affirm today that Black communities matter, that Black voices matter, that Black art matters, that Black artists matter, and that Black lives matter.
