SUBJECT: Cash Handling Changes for Parks and Recreation Department Facilities

This fall, the Parks and Recreation Department (Department) will be implementing changes to Department's cash handling policies. These changes will improve efficiencies in the collection and processing of City funds and will improve the security of City funds and City employees working at more than sixty locations in the City.

Effective October 4, 2019, all payments for park permits, class registration, weight room fees, and merchandise sales must be paid via a credit card, gift card, debit card or ECP (Electronic Check Processing) transaction. Cash (and paper check) transactions will no longer be allowed. This action will reduce the amount of cash collected and processed by Department employees by approximately \$4 million annually at the Department's permit center, recreation centers and aquatic complexes.

Small cash transactions will continue to be allowed for daily pool admissions and snack sales at teen centers and at sports events. Cash operations may be considered for non-routine special event admission and sales. These instances will be reviewed on a case by case basis and require prior approval.

In addition to providing greater security for employees and City funds, these changes will improve efficiencies in the delivery of services by allowing employees to focus on facility management and recreational programs.
