### Item 204: Appeal of the Environmental Determination for Hillcrest 111 - Project No. 522075.

<u>Total Estimated Cost of Proposed Action and Funding Source:</u>
None associated with this action. All fees are paid through a deposit account funded by the applicant.

#### **Proposed Actions:**

Appeal of Mitigated Negative Declaration No. 522075 for a Neighborhood Development Permit (NDP) to allow the demolition of an existing surface parking lot and the development of a 136,816-square-foot, seven story, mixed-use development. The project includes an Affordable Housing Density Bonus with associated Development Incentives, 4,800 square feet of commercial space and 111 residential dwelling units (102 market rate and nine very-low income units) with 190 underground parking spaces. The project also includes a detached, subterranean, 86-space parking structure to serve the adjacent AT&T facility. The 0.96-acre site is located at 635 Robinson Avenue, at the southwest corner of Robinson Avenue and 7th Avenue, in the CC-3-9 and RM-3-9 zones, within the Uptown Community Plan area. The scope of the subject hearing only includes the environmental determination and not the NDP.

Take the following actions:

According to San Diego Municipal Code Section 112.0520(e) Power to Act on Appeal. The City Council shall consider the appeal and may:

- (1) By a majority vote, deny the appeal, approve the environmental determination to adopt Mitigated Negative Declaration (MND) No. 522075 and the associated Mitigation Monitoring and Reporting Program (MMRP); or
- (2) By a majority vote, grant the appeal and set aside the environmental determination, in accordance with San Diego Municipal Code Section 112.0520(f);

Directing the City Attorney to prepare the appropriate Resolutions according to Section 40 of the City Charter;

If the City Council grants the appeal, the lower-decision maker's decision to approve the project shall be held in abeyance. The City Council shall retain jurisdiction to act on the revised environmental determination and associated project at a subsequent public hearing.
