

# Wanted Homicide Suspect: Michael Anderson

## \$1,000 Reward Offered

April 8, 2020

San Diego County Crime Stoppers and investigators from the San Diego Police Department's Homicide Unit are asking for the public's help in locating Michael Anderson who has been identified as the suspect responsible for the murder of 21-year-old Timothy Stewart.

*On March 16, 2020, at about 6:30 p.m., the San Diego Police Department Communications Center received a 911 call regarding an injured male who had been transported to Paradise Valley Hospital. The victim (later identified as Timothy Stewart) had sustained apparent trauma to his upper body and was transported to another hospital for medical treatment. Unfortunately, Stewart succumbed to his injuries.*

*Officers learned Stewart's injuries were related to an earlier incident, which occurred along the 5000 block of Logan Avenue. San Diego Police Homicide Detectives were called to the scene to investigate the incident. Detectives have identified 35-year-old Michael Anderson as the suspect in this case.*

### Suspect's Info:

Michael Anderson is a Black male, DOB: 11/26/1984 (35-years-old), 6' 0" tall, weighs 190 lbs., has black hair and brown eyes.
