The FY 2020 TransNet revenue and expenditure budget is \$35,268,000. Below is the breakdown of the expenditures budgeted by program, and O&M or CIP:

### **COUNCIL DISTRICT 4**

#### **QUESTION:**

Could you provide a breakdown of Regional Parks Improvement Funds for the past ten years?

#### **RESPONSE:**

The Mission Bay rents and concessions revenue is allocated to the Mission Bay Park and San Diego Regional Parks Improvement Funds (RPIF) in accordance with the San Diego City Charter, Article V, Section 55.2. RPIF is allocated based on recommendations of the Regional Park Improvement Oversight Committee and may only be expended for permanent or deferred capital improvements in San Diego's regional parks. This includes Balboa Park, Chicano Park, Chollas Lake Park, Mission Trails Regional Park, Otay River Valley Park, Presidio Park, San Diego River Park, open space parks, and coastal beaches and parks.

Please see attached Regional Parks Improvement Fund History which displays historical RPIF for the period from FY 2010 through FY 2019 by location and council district, as well as the FY 2020 Proposed allocations.
