The Planning Department is proposing a corrective action, to once again allow Educational Facilities in the RM zones as a Permitted Use. Additional amendments include allowing up to 600 students with a Neighborhood Use Permit, which currently requires a Conditional Use Permit; and allowing more than 600 students with a Conditional Use Permit, in existing zones that allow the use. Similar discretionary changes are proposed for Assembly and Entertainment Uses, including Places of Religious Assembly.

The proposed amendments were included in the 11th Update of the Land Development Code (LDC). The 11th Update included 47 code amendments; Educational Facilities, K-12 grade, and Assembly and Entertainment Uses, including Places of Religious Assembly Regulations was Item No. 15. The City Council approved the 11th Update on March 20, 2018, with the exception of this item. The Council members requested that this item be presented to them again separately, as a stand-alone item.
