This case involves a conflict of interest challenge to the City of San Diego's approval of the Disposition and Development Agreement and the Purchase and Sale Agreement related to the Hilltop & Euclid affordable family housing project. Later this year, the United States Supreme Court will hear three cases (consolidated as one matter under *Bostock*) regarding sex discrimination in the workplace under Title VII. The Court will decide whether discrimination based on one's sexual orientation or gender identity constitutes "sex" discrimination and, thus, violates Title VII. Approximately half of U.S. states, including California, prohibit this form of discrimination. The City of San Diego, among several local jurisdictions in California, has been asked by the City of San Francisco and County of Santa Clara to join an amicus brief arguing discrimination based on sexual orientation and gender identity constitutes sex discrimination. The City Attorney brings this request to the City Council to provide information on the litigation and seek direction.
