ADOPTION AGENDA, CONSENT ITEMS ORDINANCES INTRODUCED AT A PREVIOUS MEETING, READY FOR DISPENSING WITH THE READING AND ADOPTION:

* ITEM-50: Coastal Commission's Modifications to the City's Previously Conforming Ordinance and Local Coastal Program Amendment. (Torrey Pines, University, La Jolla, Pacific Beach, Mission Beach, Ocean Beach, and Peninsula; other coastal communities include Torrey Hills, Carmel Valley, Del Mar Mesa, Mira Mesa, Centre City, Barrio Logan, Otay-Mesa, San Ysidro, and Tijuana River Valley Community Plan Areas. Districts 1, 2, 6, and 8.)

ITEM DESCRIPTION:

The ordinance amends the City's previously conforming regulations per the Coastal Commission action on January 14, 2016. Coastal Commission's changes further limit the development rights for previously conforming development on property that contains or abuts a beach or coastal bluff by placing new limits on 1) maintenance, repair, alteration, and replacement; 2) reconstruction after fire, natural disaster, or act of the public enemy; and 3) expansion of previously conforming development. Previously conforming rights would be terminated when 50 percent or more of the exterior walls, or 50 percent of the capacity of the structure's lateral or vertical load resisting system is destroyed, demolished or removed.

CITY COUNCIL'S RECOMMENDATION:

Adopt the following ordinance which was introduced on 6/20/2016, Item 201. (Council voted 8-0. Councilmember Alvarez-not present):

(O-2016-137)

Amending Chapter 12, Article 7, Division 1, of the San Diego Municipal Code by amending Sections 127.0104, 127.0105, 127.0106, and 127.0111, all relating to accepting the California Coastal Commission's suggested modifications required for certification of the previously conforming Ordinance adopted as part of the 9th Update to the Land Development Code.

* ITEM-51: Amendments to the Affordable Housing Density Bonus Regulations of the Land Development Code and the City's Local Coastal Program. (Citywide.)

ITEM DESCRIPTION:

The Amendment contains five proposals to further incentivize construction of affordable housing using the Affordable Housing Density Bonus Regulations. The first increases the maximum density bonus. The second increases the maximum number of incentives. The third reduces the decision process when a Planned District Ordinance (PDO) permit is required. The fourth reduces the parking ratio for dwelling units in areas of high transit frequency consistent with Assembly Bill 744 (QB-744), and the fifth allows development of the affordable dwelling units off-site when in compliance with specified regulations.

CITY COUNCIL'S RECOMMENDATION:

Adopt the following ordinance which was amended by Council action at time of introduction on 6/21/2016, Item 332. (Council voted 8-0. Council President Pro Tem Emerald-not present):

* ITEM-52: The New One Paseo Project, Project No. 451328 - Approvals for New Mixed-Use Development of multi-family residential, commercial retail/commercial office at Del Mar Heights Road and El Camino Real, including an Addendum to a previously certified Environmental Impact Report. (Carmel Valley Community Plan Area. District 1.)

ITEM DESCRIPTION:

The Project proposes the construction of 608 residential units (800,000 square feet), 280,000 square feet of office use, and 95,871 square feet of retail use on a 23.6-acre site. The site is located south of Del Mar Heights Road between El Camino Real and High Bluff Drive in the Carmel Valley Planned District Mixed-Use Center (CVPD-MC) Zone of the Carmel Valley Community Plan. The Project, as proposed, exempts the actions from the requirement of a Planning Commission hearing and recommendation.

CITY COUNCIL'S RECOMMENDATION:

Adopt the following ordinances which were introduced on 6/27/2016, Item 200, Subitems B, C, D and E. (Council voted 8-1. Council President Lighter-nay):

ITEM DESCRIPTION:

This item is to amend the San Diego Municipal Code to include additional Park and Recreation locations to Section 56.54 related to alcohol restrictions and to amend Section 63.0120 to enact a nighttime curfew at University Heights Open Space Park (the portions depicted in Map 63.0120-A).

CITY COUNCIL'S RECOMMENDATION:
