- VI. Staff Reports Acting Executive Director Christine E. Jones reported that recruitment to fill the Executive Director position is under way, interviews had taken place, a conditional offer had been made and negotiations have ended. An announcement is anticipated to occur soon. She reported that recruitment is currently underway for the two Public Art Administrator positions, the city is currently conducting interviews to fill these positions. The recruitment for the two Arts Management Associate positions recently closed and the City is currently screening those applications. The Executive Assistant position has already gone through interviews and results for this position are expected this fall. Six of the eight positions are currently in different stages of recruitment. Jones reported that the 2017 Economic and Social Impact of the City of San Diego's Investment in Nonprofit Arts and Culture Organizations will be released this fall, the City's current campaign to promote the work of the Commission via City TV and that the City will be launching the online portal of the City's Civic Art Collection.
