## Friday, October 12, 2018

- I. <u>Call to Order</u> Commissioner Jason Whooper called the City of San Diego (City) Commission for Arts and Culture's Policy & Funding Committee to order at 8:06 a.m. at the office of the Commission for Arts and Culture (Commission), Civic Center Plaza, 1200 Third Avenue, Floor 9, Suite 924, San Diego, California 92101.
- II. Non-agenda Public Comment -
  - Alexandra Kritchevsky (The New Children's Museum) commented about upcoming artist residencies at the New Children's Museum and the impact of the OSP funding the museum receives from the City.
- III. Chair's Reports -
  - A. <u>ACTION September 14, 2018 Meeting Minutes</u> Commissioner Jason Whooper initiated discussion on this item. Commissioner Jason Whooper made a motion to approve the Policy & Funding Committee meeting minutes of September 14, 2018. Commissioner Ann Bossler seconded the motion. The vote was 3-0-0; the motion passed.

- B. <u>Commission Business</u> Commissioner Jason Whooper reminded Commissioners about the dates for special Policy & Funding Committee meetings scheduled for October 18, 2018 to be held at City Council Committee Room and November 15, 2018 at 8:30 am to 10:00 am, location to be determined. Discussion topics for November meeting to be determined.

IV. <u>Presentation - The Award Algorithm Explained</u> – Commissioner Whooper started a discussion on this item. Acting Executive Director, Christine E. Jones provided a presentation on the history, method and function of the current algorithm used to calculate awards for the Organizational

Support Program. She noted that funding awards are calculated with an algorithm and that its dependent on several factors including the organization's annual operating income; the rank given to the organization's proposal, the total amount of funds available for distribution and the number of organizations receiving awards. She explained further that the award amount can also change based on policy limitations such as a minimum and maximum award amounts allocated. Discussion topics included measuring impact, exploring other models of funding calculations, the need for a cultural plan, the need for the curve for distribution of funds, factors that impact the funding that nonprofits can receive, eligibility requirements, a timeline for application process, calculation of the annual operating income, outreaching to diverse nonprofits, examining the arts and culture ecosystem, and the City's discontinuance of limiting award amounts for new applicants in FY19 funding cycle to ensure fair procurement practice.

### Public Comment -

- Peter Comiskey (Balboa Park Cultural Partnership) commented on the funding algorithm and the impact of funded organizations, both large and small.
- V. <u>Discussion Long-term Arts and Culture Budget Distribution Priorities</u> Commissioner Whooper initiated discussion on this item. Discussion topics included cultural and strategic planning, allocating funds in budget priorities for a cultural plan, cultural plan funding spread over multiple years, cultural plan as a long-term goal. Suggestion to discuss the Organizational Support Program and Creative Communities Request for Proposals evaluation panel process during the next special Policy & Funding Committee meeting.

#### Public Comment -

- Jane Merril (San Diego Youth Symphony) commented on the impact of San Diego Youth Symphony programs on local students and in support of Organizational Support Program funding.
- Peter Comiskey (Arts and Culture San Diego) commented on the need for a cultural plan, and the impact on the arts of funded organizations.
- Todd Schultz (San Diego Symphony) commented on the funding algorithm, and the need for continued support of smaller organizations.

#### VI. Staff Reports –

Acting Executive Director Christine E. Jones called on Civic Art Project Manager Leticia Gomez Franco to report on the status of FY19 and FY20 funding cycles for Organizational Support Program and Creative Communities San Diego. Gomez Franco reported that the City received 27 eligible applications for the Fiscal Year 2019 Arts Education Enrichment Initiative, and those were scheduled to be reviewed by the Commission Advisory Panel for Fiscal Year 2019 Arts Education Enrichment Initiative on Wednesday October 17<sup>th</sup>. She also reported that contracting for the Fiscal Year 2019 Organizational Support Program and Creative Communities San Diego funding cycle is in the contracting phase and that the office's internal Key Performance Indicator of having 50% of FY19 contracts routed for signature by October 31st was met at the end of August; currently, there are 75% of FY19 contracts in routing or already executed. The Fiscal Year 2020 funding cycle Request for Qualifications and application guidelines for Organizational Support Program and Creative Communities San Diego were released in September and deadline to apply is October 19<sup>th</sup>. Staff is currently holding office hours for applicants. Staff also recently released a Call for Commission Advisory Panelist Nominations and deadline to submit those is Monday October 29<sup>th</sup>.

VII. New Business for Future Agendas - Commissioner Jason Whooper recommended the Organizational Support Program and Creative Communities San Diego evaluation panel process as the topic of discussion for the special Policy & Funding Committee meeting to be held on Thursday, November 15<sup>th</sup>, 2018 at 8:30 am location to be determined. Topics for future special meetings would be discussed at future meetings. Discussion topics included discussing the cultural plan, measuring impact, return on investment and funding caps.
