- I. CALL TO ORDER/WELCOME: 12:03 p.m.
- II. PURPOSE OF THE COMMUNITY REVIEW BOARD ON POLICE PRACTICES: Chair Joe Craver waived the reading of the purpose of the Community Review Board on Police Practices because no one from the public was present.
- III. PURPOSE OF THE EXECUTIVE COMMITTEE: Chair Joe Craver waived the reading of the purpose of the Executive Committee because no one from the public was present.
- IV. APPROVAL OF EXECUTIVE COMMITTEE MEETING MINUTES FROM JULY 17, 2019: Member Mary O'Tousa moved for the Committee to approve the

meeting minutes of July 17, 2019. 1st Vice Chair Brandon Hilpert seconded the motion. The motion passed with a vote of 4-0-0.

V. SAN DIEGO POLICE DEPARTMENT REPORT

- A. Case load for CRB (Category I, Discipline Reports, Officer-Involved Shooting Cases, In-Custody Death Cases) SDPD Captain Morris reported that there is an extensive OIS coming up for the Teams within the next couple of weeks.
- B. Shared Database Update SDPD's IT Department is having an issue getting the system data to the Executive Director's office computer. They will be using the city's OKTA system to share the data. The Executive Director will be able to access the data using the OKTA application. In the meantime, Internal Affairs is putting the information on a CD for the Executive Director.
- C. IA Logistics—Captain Morris addressed the following concerns raised by the CRB Team leaders:
 - Missing Documents All documents should be in the case file. If anything is missing, the Team should notify Detective Amado.
 Detective Amado will notify Captain Morris.
 - Flexible IA Hours Internal Affairs is willing to make accommodations and have flexible hours for CRB members. Staff is not always in Internal Affairs, so notice is required.
 - Labeling of BWC Video- The original ask was for videos to be renamed & should be able to be cross referenced. The suggested and agreed solution is for the Teams to change the name on the flash drive and use it with the cross-reference sheet. Captain Morris asked Detective Amado to research whether the Sgts. can change the labels.
 - IA Staffing Changes Captain Morris reported that they try to announce staffing changes at the CRB meetings. Charles Lara is taking Mark Bennett's spot. Sgt. Jared Thompson is taking Sgt. Rich Fox's place and Sgt. Van Pen will be replacing Sgt. Gutierrez who is now a Lieutenant. In response to the CRB's request, Captain Morris will allow Investigative Sergeants attendance at the CRB Closed Meetings. Everyone agreed that it is an important learning experience for the Investigative Sergeants.
 - Thoroughness of IA Investigations Captain Morris reported that he received feedback from the CRB that some of the investigative reports

are not thorough and the investigators are not asking follow-up questions. He asked the members to bring this issue up with the Sergeant if they see a problem with any investigation. If that does not work, the members can always contact the Lieutenant and Captain if necessary.

- D. Joint Complaint Form Status The joint complaint form was released last month. People have started using them. Lt. Bennett is working on getting the complaint form translated into Spanish. The forms will also be available at SDPD's Mobile Command Station.

 - D. Outreach Committee Committee Chair Mary O'Tousa will need 5
 minutes for her report. She will announce the new sign-up sheet in
 addition to the listed items under her Committee report.
 - E. Rules Committee Committee Chair Doug Case requested that item I be a discussion item. He handed out copies of samples of redacted case summaries agreed upon by the Committee and Outside Counsel to include with the Open Meeting Agenda. The Committee needs feedback from the Board, so this is only a discussion item. Committee Chair Case will need 10 minutes for the discussion.
 - F. CRB Handbook Committee Committee Chair Doug Case reported that the Committee was waiting to complete the Standing Rule and get the guidelines for ride-alongs and radio codes from Internal Affairs. Executive Director Moseley will follow-up with Administrative Aide Sonja Mack to check on the status of the other items. Committee Chair Doug Case will stop by CRB office to look at the sample revised copy. This item will be moved up on the agenda and added after the report from the Rules Committee. Committee Chair Case requested 2 minutes for his report.

- G. Policy Committee Committee Chair Brandon Hilpert requested 5 minutes for his report.
- H. Recruitment and Training Committee Chair Craver gave Committee Chair Nieto-Senour 5 minutes for her report.
- I. Citizens Advisory Board on Police Community Relations (Taura Gentry) Chair Craver gave Committee Chair Gentry 1 minute for her report since the Board was dark this month.
- J. 30th Anniversary Celebration Date Committee Chair Brandon Hilpert reported that yesterday a doodle poll went out to the Board. So far, the best date is in October. The event will be from 5pm—7:30pm at the Central Library.
- K. Chair Craver requested an updated work plan from 1st Vice Chair Brandon Hilpert. CRB Executive Director and 2nd Vice Chair will be attending NACOLE. Leadership will decide before the Open Meeting if they will cancel or reschedule the CRB's Open Meeting on September 24.
- L. Executive Director Moseley requested 5 minutes for her report.
- M. Captain Morris requested 5 minutes for the Chief's report.

Executive Director Moseley stated that this is item VIII (A) on the agenda. 2nd Vice Chair Taura Gentry will lead this discussion.
- B. Feedback on 8/14 Recruitment Informational Session Chair Craver reported that this was an excellent session. We had 12 attendees. The attendees had great questions. Ten attendees were interested in the CRB.

- D. Update on 8/13 Team Leaders Meeting This item was discussed under the San Diego Police Department's Report on this agenda (item V).
- E. IA Tablets 1st Vice Chair Hilpert requested that the files be unlocked so that the members can make comments. Detective Amado will look into pdf's so the members can write and highlight. Members can use a stylus and write on the report if it is in pdf format.
