Item 1 - Discuss and Vote on Proposed Changes to the [updated Preliminary Redistricting Map](#)  
Including:

- Subitem A: Review moving the Old Town Community Planning Area (CPA) to District 2.
- Subitem B: Review moving the western portion of the Penasquitos Canyon and the east end of the Torrey Pines Preserve to District 1.
- Subitem C: Review moving Mission Valley East (east of I-15 and north of I-8) from District 9 to District 7, adding Stockton to District 9, and moving Morena to District 2.
- Subitem D: Evaluate ways to decrease the population in District 5 by moving portions of Scripps Ranch to District 6 and/or moving part of Torrey Highlands to District 1.
- Subitem E: Evaluate moving part of Mountain View to District 9 and offset it with moving Mission Valley east of I-15 and north of I-8 to District 7, and analyze moving Stockton to District 9 and offset it with moving Mission Valley east of I-15 and north of I-8 to District 7.

Until further notice, meetings will be conducted pursuant to the provisions of California Government Code section 54953(e), added by Assembly Bill 361, which allows the Commission to use teleconferencing and to provide the public an opportunity to address the Commission via a call-in option or an internet-based service option, during a proclaimed state of emergency when measures to promote social distancing are in effect or the Commission has determined meeting in person would present imminent risks to the health or safety of attendees.

During the current State of Emergency and in the interest of public health and safety, all members of the Redistricting Commission will be participating in meetings by teleconference. Comments received after the start of the meeting but before the item is called will be submitted into the written record for the relevant item.

Non-Agenda Public Comment may be submitted using the [webform](#), checking the appropriate box. Comments received by the start of the meeting will be distributed to the Commission and posted online with the meeting materials. All webform comments are limited to 200 words. Comments received after the start of the meeting but before Non-agenda comment is called will be submitted into the written record for the meeting.

Materials submitted via e-mail will be distributed to the Commission in accordance with the deadlines described above.
