SAN DIEGO WATER QUALITY: WHAT'S IN YOUR GLASS?

Water is an expensive resource that must be transported and properly treated to make sure it is safe and healthful. Every year we issue a Drinking Water Quality Report with details about where your water comes from, what it contains, and how it compares to state land or through the ground, it dissolves naturally-occurring minerals and can pick up substances resulting from the presence of animals or from human activity. The City treats the water at three treatment plants: Alvarado, Miramar and Otay. District Five receives its

standards. The City of San Diego Public Utilities Department is proud to report once again that our system has never violated a state or federal drinking water health standard.

San Diego imports approximately 85% to 90% of its water. Our water supply is a blend from the Colorado River, State Water Project (Northern California), and local sources.

The sources of drinking water (both

The addition of this storefront will improve response times, department efficiency and working conditions for officers. It will also increase coordination with community groups. Volunteer public safety groups—

Neighborhood Watch and Retired Senior Volunteer Patrol—are also based at this location.

Having officers in the communities they serve improves relationships and access, and ultimately keeps San Diegans safer.

PROTECTING YOUR HOME

Burglary is primarily a crime of opportunity. Here are a few handy tips from the Police Department.

SECURE YOUR HOME

- Install single-cylinder dead-bolt locks on all doors. Doors should be solid hardwood or metal clad. Hinges should be located inside or have non-removable pins.
- Re-key or change locks when moving into a new home.
- Install "bumping" resistant locks on garages and sheds.
- Use burglar-resistant glass that meets UL 972 standards in vulnerable windows and doors.

LOCK IT & BLOCK IT

- Keep valuables in a bank safe deposit box or hidden, bolted-down home safe.
- Side and back entries are the most common access points for burglars. Gates and adjacent fencing should be at least 6 feet high, have a

good lock, and be locked at all times.

• Keep all doors and windows locked, even if you are just going out "for a minute."

PROTECT YOUR IDENTITY

- Don't leave notes on your door when you are away.
- Don't leave keys under doormats or in other obvious hiding spots.
- Ask for photo ID before letting in service providers.
- Don't leave your home keys with parking valets, and don't leave your garage door opener where it is easily accessible. Hide any papers that contain your address.

• Don't give maids, babysitters, or others working in your home access to keys or alarm codes.

• Never let a stranger in to use the phone. Make the call yourself in an emergency.
